Resolved, That the bill from the House of Representatives (H.R. 1021) entitled "An Act to prevent the termination of the temporary office of bankruptcy judges in certain judicial districts.", do pass with the following

## **AMENDMENT:**

Strike section 3 and insert the following:

### 1 SEC. 3. BANKRUPTCY FILING FEE INCREASE.

- 2 (a) Bankruptcy Filing Fees.—Section 1930(a)(3)
- 3 of title 28, United States Code, is amended by striking
- 4 "\$1,000" and inserting "\$1,167".
- 5 (b) United States Trustee System Fund.—Sec-
- 6 tion 589a(b)(2) of title 28, United States Code, is amended
- 7 by striking "55" and inserting "48.89".
- 8 (c) Collection and Deposit of Miscellaneous
- 9 Bankruptcy Fees.—Section 406(b) of the Judiciary Ap-
- 10 propriations Act, 1990 (28 U.S.C. 1931 note) is amended
- 11 by striking "25" and inserting "33.33".

- 1 (d) Paygo Offset Expenditure Limitation.—\$42
- 2 of the incremental amounts collected by reason of the enact-
- 3 ment of subsection (a) shall be deposited in a special fund
- 4 in the Treasury to be established after the date of enactment
- 5 of this Act. Such amounts shall be available for the purposes
- 6 specified in section 1931(a) of title 28, United States Code,
- 7 but only to the extent specifically appropriated by an Act
- 8 of Congress enacted after the date of enactment of this Act.
- 9 (e) Effective Date.—This section and the amend-
- 10 ments made by this section shall take effect 180 days after
- 11 the date of enactment of this Act.
- 12 SEC. 4. SUBSEQUENT REAUTHORIZATION.
- 13 Prior to further reauthorization of any judgeship au-
- 14 thorized by this Act, the Committee on the Judiciary of the
- 15 Senate and House of Representatives shall conduct a review
- 16 of the bankruptcy judgeships authorized by this Act to deter-
- 17 mine the need, if any, for continued reauthorization of each
- 18 judgeship, to evaluate any changes in all bankruptcy case
- 19 filings and their effect, if any, on filing fee revenue, and
- 20 to require the Administrative Office of the Courts to submit
- 21 a report to the Committee on the Judiciary of the Senate
