Mr. HASTINGS (for himself, Mr. JOHNSON of Georgia, Mr. RANGEL, Ms. NORTON, Mr. CUMMINGS, Mr. PAYNE, Ms. JACKSON LEE, and Mr. SERRANO) introduced the following bill; which was referred to the Committee on Foreign Affairs

A BILL

To provide for the establishment of a global affairs strategy and assistance for people of African descent, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “African Descent Af-
5 fairs Act of 2015”.

6 **SEC. 2. FINDINGS.**

7 Congress finds the following:

8 (1) The struggle to end discrimination against
9 people of African descent is a global challenge, and

1 one that is central to the United States commitment
2 to human rights.

3 (2) Targeted exclusion, violence, and discrimi-
4 nation against people of African descent continues
5 around the world.

6 (3) Issues range from the fight for ancestral
7 lands in Latin America, hate crimes resulting in in-
8 jury and death in Europe, to profiling and excessive
9 use of force by law enforcement in the United
10 States, and continuing global disparities in health,
11 education, employment, housing, and other sectors.

12 (4) It is imperative that the world actively ad-
13 dress the vestiges of slavery and colonialism that
14 have long hindered racial equality and justice and
15 prevented the recognition of the important contribu-
16 tions of people of African descent to the world.

17 (5) The International Decade for People of Af-
18 rican Descent, from January 1, 2015, to December
19 31, 2025, offers an opportunity to address these
20 issues domestically and globally through coordinated
21 government and civil society strategies, that include
22 the private sector.

23 **SEC. 3. ACTIVITIES OF THE DEPARTMENT OF STATE.**

24 (a) OFFICE OF GLOBAL AFRICAN DESCENT AF-
25 FAIRS.—Title I of the State Department Basic Authorities

1 Act of 1956 (22 U.S.C. 2651a et seq.) is amended by add-
2 ing at the end the following new section:

3 **“SEC. 63. OFFICE OF GLOBAL AFRICAN DESCENT AFFAIRS.**

4 “(a) ESTABLISHMENT OF OFFICE.—Not later than
5 60 days after the date of enactment of this section, the
6 Secretary of State shall establish within the Department
7 of State an Office of Global African Descent Affairs (in
8 this section referred to as the ‘Office’) in the Bureau of
9 Public Diplomacy and Public Affairs.

10 “(b) HEAD OF OFFICE.—

11 “(1) IN GENERAL.—The head of the Office
12 shall be the Director and Special Advisor to the Sec-
13 retary on Global African Descent Affairs (in this
14 section referred to as the ‘Special Advisor’).

15 “(2) APPOINTMENT.—The Director shall be ap-
16 pointed by the Secretary.

17 “(c) OTHER PERSONNEL.—The Office shall be sup-
18 ported by two senior Foreign Service officers.

19 “(d) FUNCTIONS.—The functions of the Office shall
20 include the following:

21 “(1) Advise the Secretary and direct activities,
22 policies, programs, and funding relating to the
23 human rights and the advancement of people of Af-
24 rican descent internationally, for all bureaus and of-
25 fices of the Department of State and shall lead the

1 coordination, monitoring, and evaluation of relevant
2 international programs for all other Federal agen-
3 cies.

4 “(2) Represent the United States in diplomatic
5 matters relevant to the human rights of people of
6 African descent in contacts with foreign govern-
7 ments, intergovernmental organizations, and special-
8 ized agencies of the United Nations, the Organiza-
9 tion of Security and Cooperation in Europe, other
10 international organizations of which the United
11 States is a member, and relevant multilateral con-
12 ferences and meetings.

13 “(3) Lead efforts to promote an international
14 focus on racial equality more broadly, including
15 through diplomatic initiatives with other countries
16 and partnerships and regular and enhanced coordi-
17 nation with international and nongovernmental orga-
18 nizations and the private sector.

19 “(4) Develop and manage the President Obama
20 Fund for African Descent Affairs, established under
21 section 3(c) of the African Descent Affairs Act of
22 2015, for the purpose of investing in efficient and
23 innovative solutions to combat racial discrimination
24 and create economic and political opportunities for
25 people of African descent internationally.

1 “(5) Develop a uniform set of indicators and
2 standards for monitoring and evaluating foreign pol-
3 icy assistance for people of African descent in Fed-
4 eral agencies.

5 “(6) Direct, as appropriate, United States Gov-
6 ernment resources to respond to needs for protec-
7 tion, integration, resettlement, and empowerment of
8 people of African descent in United States Govern-
9 ment policies and international programs, including
10 to prevent and respond to discrimination and vio-
11 lence against people of African descent internation-
12 ally.

13 “(7) Develop and coordinate United States Gov-
14 ernment international efforts related to the imple-
15 mentation of the International Decade for People of
16 African Descent and submit annual reports to Con-
17 gress on these efforts.

18 “(8) Work in collaboration with the Race, Eth-
19 nicity, and Social Inclusion Unit in the Western
20 Hemisphere Bureau and consult with the Bureau of
21 African Affairs.

22 “(9) Compile an annual report on activities of
23 the United States Government relating to people of
24 African descent to fulfill the requirements of this
25 section and the African Descent Affairs Act of 2015.

1 “(e) DEFINITIONS.—In this section:

2 “(1) APPROPRIATE CONGRESSIONAL COMMIT-
3 TEES.—The term ‘appropriate congressional com-
4 mittees’ means—

5 “(A) the Committee on Foreign Relations
6 and the Committee on Appropriations of the
7 Senate; and

8 “(B) the Committee on Foreign Affairs
9 and the Committee on Appropriations of the
10 House of Representatives.

11 “(2) PEOPLE OF AFRICAN DESCENT.—The
12 term ‘people of African descent’ has the meaning
13 given the term in section 5 of the African Descent
14 Affairs Act of 2015.”.

15 (b) ANNUAL HUMAN RIGHTS REPORT.—

16 (1) IN GENERAL.—The Foreign Assistance Act
17 of 1961 is amended—

18 (A) in section 116 (22 U.S.C. 2151n), by
19 adding at the end the following new subsection:

20 “(h) STATUS OF PEOPLE OF AFRICAN DESCENT.—

21 “(1) IN GENERAL.—The report required under
22 subsection (d) shall include, for countries in the
23 Americas, Europe, Asia, and the Middle East, a de-
24 scription of the status of people of African descent
25 in each such country.

1 “(2) DEFINITION.—In this subsection, the term
2 ‘people of African descent’ has the meaning given
3 the term in section 5 of the African Descent Affairs
4 Act of 2015.”; and

5 (B) in section 502B (22 U.S.C. 2304)—

6 (i) by redesignating the second sub-
7 section (i) (as added by section 1207(b)(2)
8 of Public Law 113–4) as subsection (j);
9 and

10 (ii) by adding at the end the following
11 new subsection:

12 “(k) STATUS OF PEOPLE OF AFRICAN DESCENT.—

13 “(1) IN GENERAL.—The report required under
14 subsection (b) shall include, for countries in the
15 Americas, Europe, Asia, and the Middle East, a de-
16 scription of the status of people of African descent
17 in each such country.

18 “(2) DEFINITION.—In this subsection, the term
19 ‘people of African descent’ has the meaning given
20 the term in section 5 of the African Descent Affairs
21 Act of 2015.”.

22 (2) EFFECTIVE DATE.—The amendments made
23 by this subsection take effect on the date of the en-
24 actment of this Act and apply with respect to re-
25 ports required to be submitted under sections 116

1 and 502B of the Foreign Assistance Act of 1961, as
2 amended by this subsection, on or after such date of
3 enactment.

4 (c) AUTHORIZATION OF APPROPRIATIONS.—

5 (1) IN GENERAL.—There is authorized to be
6 appropriated to the Secretary of State \$5,000,000
7 for each of the fiscal years 2016 through 2027 to
8 carry out this section and the amendments made by
9 this section.

10 (2) PRIVATE CONTRIBUTIONS.—Notwith-
11 standing any other provision of law, the Secretary of
12 State is authorized to accept private contributions to
13 carry out this section and the amendments made by
14 this section.

15 (3) DESIGNATION.—Amounts appropriated pur-
16 suant to the authorization of appropriations under
17 paragraph (1) and private contributions accepted
18 under paragraph (2) may be referred to as the
19 “President Obama Fund for African Descent Af-
20 fairs”.

21 **SEC. 4. ACTIVITIES OF THE UNITED STATES AGENCY FOR**
22 **INTERNATIONAL DEVELOPMENT.**

23 (a) SENIOR ADVISOR.—

24 (1) IN GENERAL.—The Administrator of the
25 United States Agency for International Development

1 shall appoint within the immediate office of the Ad-
2 ministrator a Senior Advisor to the Administrator on
3 Global African Descent Affairs (in this section re-
4 ferred to as the “Senior Advisor”).

5 (2) APPOINTMENT.—The Senior Advisor shall
6 be appointed by the Administrator.

7 (b) FUNCTIONS.—The functions of the Senior Advi-
8 sor shall include the following:

9 (1) Advise the Administrator and direct activi-
10 ties, policies, programs, and funding relating to the
11 human rights and advancement of people of African
12 descent internationally for all bureaus and offices of
13 the Agency.

14 (2) Develop a racial and ethnic equality and
15 empowerment policy, strategy, and action plan for
16 the Agency, in consultation with civil society, that
17 includes a focus on people of African descent.

18 (3) Serve as the Agency liaison to the Depart-
19 ment of State’s Office of Global African Descent Af-
20 fairs.

21 (4) Develop a uniform set of indicators and
22 standards for monitoring and evaluating foreign as-
23 sistance for people of African descent in Federal
24 agencies.

1 (c) AUTHORIZATION OF APPROPRIATIONS.—There is
2 authorized to be appropriated to the Administrator
3 \$3,000,000 for each of the fiscal years 2016 through 2027
4 to carry out this section.

5 **SEC. 5. DEFINITIONS.**

6 In this Act:

7 (1) APPROPRIATE CONGRESSIONAL COMMIT-
8 TEES.—The term “appropriate congressional com-
9 mittees” means—

10 (A) the Committee on Foreign Relations
11 and the Committee on Appropriations of the
12 Senate; and

13 (B) the Committee on Foreign Affairs and
14 the Committee on Appropriations of the House
15 of Representatives.

16 (2) PEOPLE OF AFRICAN DESCENT.—The term
17 “people of African descent” means persons of Afri-
18 can origin who are residents of countries of the
19 Americas, Europe, Asia, and the Middle East.

20 **SEC. 6. BRIEFINGS AND ASSESSMENTS.**

21 Not later than 180 days after the date of the enact-
22 ment of this Act, and annually thereafter, the Director
23 and Special Advisor to the Secretary on Global African
24 Descent Affairs (appointed under section 63 of the State

1 Department Basic Authorities Act of 1956 (as added by
2 section 3 of this Act))—

3 (1) shall brief the appropriate congressional
4 committees on the status of the human rights, social
5 inclusion, equality, and empowerment of people of
6 African descent internationally, as well as the status
7 of programs and response strategies to address dis-
8 crimination and violence against people of African
9 descent internationally; and

10 (2) shall submit to the appropriate congres-
11 sional committees an assessment of human and fi-
12 nancial resources necessary to fulfill the purposes
13 and duties of this Act and the amendments made by
14 this Act.

15 **SEC. 7. UNITED STATES POLICY TO PREVENT AND RE-**
16 **SPOND TO DISCRIMINATION AND VIOLENCE**
17 **AGAINST PEOPLE OF AFRICAN DESCENT.**

18 (a) GLOBAL STRATEGY REQUIREMENT.—Not later
19 than 180 days after the date of the enactment of this Act,
20 and annually thereafter for 10 years, the Director and
21 Special Advisor to the Secretary on Global African De-
22 scent Affairs shall develop or update a United States glob-
23 al strategy to empower, prevent, and respond to discrimi-
24 nation and violence against people of African descent. The
25 strategy shall be transmitted to the appropriate congres-

1 sional committees and, if practicable, made available to
2 the public.

3 (b) COLLABORATION AND COORDINATION.—In devel-
4 oping the strategy under subsection (a), the Director and
5 Special Advisor to the Secretary on Global African De-
6 scent Affairs shall consult with—

- 7 (1) the heads of relevant Federal agencies; and
8 (2) representatives of civil society, multilateral,
9 and private sector organizations.

10 **SEC. 8. SUNSET.**

11 This Act and the amendments made by this Act shall
12 terminate on October 1, 2027.
