# **A BILL**

To repeal the natural gas tax.

1        *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4        This Act may be cited as the “Natural Gas Tax Re-  
5 peal Act”.

6 **SEC. 2. REPEAL.**

7        Section 136 of the Clean Air Act (42 U.S.C.  
8 7436)(relating to methane emissions and waste reduction  
9 incentive program for petroleum and natural gas systems)  
10 is repealed.

11 **SEC. 3. RESCISSION.**

12        The unobligated balance of any amounts made avail-  
13 able under section 136 of the Clean Air Act (42 U.S.C.  
14 7436)(as in effect on the day before the date of enactment  
15 of this Act) is rescinded.
