# A BILL

To promote and protect from discrimination living organ  
donors.

1       *Be it enacted by the Senate and House of Representa-*

2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Living Donor Protec-

5       tion Act of 2019”.

1     **SEC. 2. PROHIBITION ON DENIAL OF COVERAGE OR IN-**  
2                 **CREASE IN PREMIUMS OF LIFE OR DIS-**  
3                 **ABILITY INSURANCE FOR LIVING ORGAN DO-**  
4                 **NORS.**

5         (a) PROHIBITION.—Notwithstanding any other provi-  
6 sion of law, it shall be unlawful to—

7                 (1) decline or limit coverage of a person under  
8 any life insurance policy, disability insurance policy,  
9 or long-term care insurance policy, due to the status  
10 of such person as a living organ donor;

11                 (2) preclude a person from donating all or part  
12 of an organ as a condition of receiving a life insur-  
13 ance policy, disability insurance policy, or long-term  
14 care insurance policy;

15                 (3) consider the status of a person as a living  
16 organ donor in determining the premium rate for  
17 coverage of such person under a life insurance pol-  
18 icy, disability insurance policy, or long-term care in-  
19 surance policy; or

20                 (4) otherwise discriminate in the offering,  
21 issuance, cancellation, amount of such coverage,  
22 price, or any other condition of a life insurance pol-  
23 icy, disability insurance policy, or long-term care in-  
24 surance policy for a person, based solely and without  
25 any additional actuarial risks upon the status of  
26 such person as a living organ donor.

1       (b) ENFORCEMENT.—A State insurance regulator  
2 may take such actions to enforce subsection (a) as are spe-  
3 cifically authorized under the laws of such State.

4       (c) DEFINITIONS.—In this section:

5           (1) DISABILITY INSURANCE POLICY.—The term  
6       “disability insurance policy” means a contract under  
7       which an entity promises to pay a person a sum of  
8       money in the event that an illness or injury resulting  
9       in a disability prevents such person from working.

10          (2) LIFE INSURANCE POLICY.—The term “life  
11       insurance policy” means a contract under which an  
12       entity promises to pay a designated beneficiary a  
13       sum of money upon the death of the insured.

14          (3) LIVING ORGAN DONOR.—The term “living  
15       organ donor” means an individual who has donated  
16       all or part of an organ and is not deceased.

17          (4) LONG-TERM CARE INSURANCE POLICY.—  
18       The term “long-term care insurance policy” means  
19       a contract for which the only insurance protection  
20       provided under the contract is coverage of qualified  
21       long-term care services (as defined in section  
22       7702B(c) of the Internal Revenue Code of 1986).

1   **SEC. 3. CLARIFICATION OF ORGAN DONATION SURGERY AS**  
2                   **QUALIFYING AS A SERIOUS HEALTH CONDI-**  
3                   **TION UNDER FMLA.**

4       (a) PRIVATE SECTOR EMPLOYEES.—Section 101(11)  
5   of the Family and Medical Leave Act of 1993 (29 U.S.C.  
6 2611(11)) is amended by inserting “(including recovery  
7 from surgery related to organ donation)” after “physical  
8 or mental condition”.

9       (b) FEDERAL CIVIL SERVICE EMPLOYEES.—

10              (1) DEFINITION.—Section 6381(5) of title 5,  
11   United States Code, is amended by inserting “(in-  
12   cluding recovery from surgery related to organ dona-  
13   tion)” after “physical or mental condition”.

14              (2) RELATIONSHIP TO ORGAN DONOR LEAVE.—  
15   Section 6382(d) of title 5, United States Code is  
16   amended by adding at the end the following: “An  
17   employee who takes any part of the 12-week period  
18   of leave under subsection (a)(1) to serve as an organ  
19   donor (including recovery from surgery related to  
20   organ donation) shall substitute, for as much of that  
21   part as possible, any leave available to the employee  
22   under section 6327.”.

23   **SEC. 4. UPDATING OF EDUCATIONAL MATERIALS ON THE**  
24                   **BENEFITS OF LIVE ORGAN DONATION.**

25       (a) EDUCATIONAL MATERIALS.—

1                             (1) REVIEW AND UPDATING.—Not later than 6  
2 months after the date of enactment of this Act, the  
3 Secretary of Health and Human Services (in this  
4 section referred to as the “Secretary”) shall review  
5 and update materials related to live organ donation  
6 in order to educate the public on—

7                             (A) the benefits of live organ donation; and  
8                             (B) the impact of live organ donation on  
9 the access of a living organ donor to insurance.

10                           (2) INFORMATION ON STATUTORY CHANGES.—  
11 Such updating shall include information on the  
12 changes made by sections 2 and 3 of this Act.

13                           (b) METHODS OF UPDATING.—In carrying out sub-  
14 section (a), the Secretary shall update, as appropriate—

15                           (1) Public Service Announcements previously  
16 provided by the Secretary;

17                           (2) publicly accessible Web sites (such as  
18 organdonor.gov, or a successor Web site) that are  
19 maintained by the Secretary and that contain infor-  
20 mation and resources regarding live organ donation;  
21 and

22                           (3) other media determined appropriate by the  
23 Secretary.
