## A BILL

To establish a program to increase drinking water and wastewater system threat preparedness and resilience, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Water System Threat  
5 Preparedness and Resilience Act of 2023”.

6 **SEC. 2. PROGRAM ESTABLISHMENT.**

7 (a) DEFINITIONS.—In this section:

1           (1) COMMUNITY WATER SYSTEM.—The term  
2           “community water system” has the meaning given  
3           the term in section 1401 of the Safe Drinking Water  
4           Act (42 U.S.C. 300f).

5           (2) NATURAL HAZARD.—The term “natural  
6           hazard” has the meaning given the term in section  
7           1433(h) of the Safe Drinking Water Act (42 U.S.C.  
8           300i–2(h)).

9           (3) TREATMENT WORKS.—The term “treatment  
10          works” has the meaning given the term in section  
11          212 of the Federal Water Pollution Control Act (33  
12          U.S.C. 1292).

13          (4) WATER INFORMATION SHARING AND ANAL-  
14          YSIS CENTER.—The term “Water Information Shar-  
15          ing and Analysis Center” means the Information  
16          Sharing and Analysis Center referenced in section  
17          1435(d) of the Safe Drinking Water Act (42 U.S.C.  
18          300i–4(d)).

19          (b) ESTABLISHMENT.—Not later than 1 year after  
20          the date of enactment of this Act, the Administrator of  
21          the Environmental Protection Agency shall develop and  
22          carry out a program—

23                 (1) to encourage, support, and maintain the  
24                 participation of community water systems, treatment

1 works, and other appropriate entities in the Water  
2 Information Sharing and Analysis Center;

3 (2) to offset costs incurred by community water  
4 systems and treatment works that are necessary to  
5 maintain or initiate membership in the Water Infor-  
6 mation Sharing and Analysis Center;

7 (3) to expand the cooperation and coordination  
8 of the Environmental Protection Agency with the  
9 Water Information Sharing and Analysis Center  
10 with respect to incident data collection and analysis  
11 of water sector-related threats; and

12 (4) to enhance the tools, resources, and mate-  
13 rials of the Water Information Sharing and Analysis  
14 Center for—

15 (A) monitoring the status of the water sec-  
16 tor; and

17 (B) enhancing the preparedness of commu-  
18 nity water systems and publicly owned treat-  
19 ment works to identify, protect against, detect,  
20 respond to, and recover from malevolent acts  
21 (within the meaning of section 1433 of the Safe  
22 Drinking Water Act (42 U.S.C. 300i-2)) or  
23 natural hazards.

24 (c) AUTHORIZATION OF APPROPRIATIONS.—There is  
25 authorized to be appropriated to carry out this section

- 1 \$10,000,000 for each of fiscal years 2024 and 2025, to
- 2 remain available until expended.
