## A BILL

To require retailers who offer products for purchase through a website to disclose on such website the country of origin for each product offered for sale.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Country of Origin La-  
5 beling Requirement Act”.

6 **SEC. 2. COUNTRY OF ORIGIN DISCLOSURE REQUIREMENTS**  
7 **FOR PRODUCTS SOLD ON RETAIL WEBSITES.**

8 (a) DISCLOSURE REQUIREMENT.—Any person that  
9 operates an Internet website (including a mobile applica-

1 tion) and that sells or offers for sale any product through  
2 such website or application, shall disclose on such website  
3 or application, in a clear and conspicuous manner, the  
4 country in which such product was manufactured or fi-  
5 nally assembled.

6 (b) EXCLUSION.—The requirements in subsection (a)  
7 shall not be construed to apply to any individual who uses  
8 a website operated by another person to sell or offer for  
9 sale any good or product.

10 **SEC. 3. ENFORCEMENT BY THE FEDERAL TRADE COMMIS-**  
11 **SION.**

12 (a) UNFAIR OR DECEPTIVE ACTS OR PRACTICES.—  
13 A violation of section 1(a) shall be treated as a violation  
14 of a regulation under section 18(a)(1)(B) of the Federal  
15 Trade Commission Act (15 U.S.C. 57a(a)(1)(B)) regard-  
16 ing unfair or deceptive acts or practices.

17 (b) POWERS OF THE COMMISSION.—The Commission  
18 shall enforce section 1(a) in the same manner, by the same  
19 means, and with the same jurisdiction, powers, and duties  
20 as though all applicable terms and provisions of the Fed-  
21 eral Trade Commission Act (15 U.S.C. 41 et seq.) were  
22 incorporated into and made a part of this Act. Any person  
23 who violates such section shall be subject to the penalties  
24 and entitled to the privileges and immunities provided in  
25 the Federal Trade Commission Act.

1           (c) EFFECT ON OTHER LAWS.—Nothing in this Act  
2 shall be construed in any way to limit or affect the author-  
3 ity of the Commission under any other provision of law.
