# A BILL

To amend the National Trails System Act to clarify Federal authority relating to land acquisition from willing sellers for the majority of the trails in the System, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "National Trails System
- 5 Willing Seller Act".

### 1 SEC. 2. AUTHORITY TO ACQUIRE LAND FROM WILLING

- 2 SELLERS FOR CERTAIN TRAILS.
- 3 (a) Oregon National Historic Trail.—Section
- 4 5(a)(3) of the National Trails System Act (16 U.S.C.
- 5 1244(a)(3)) is amended by adding at the end the fol-
- 6 lowing: "No land or interest in land outside the exterior
- 7 boundaries of any federally administered area may be ac-
- 8 quired by the Federal Government for the trail except with
- 9 the consent of the owner of the land or interest in land.
- 10 The authority of the Federal Government to acquire fee
- 11 title under this paragraph shall be limited to an average
- 12 of not more than ½ mile on either side of the trail.".
- 13 (b) Mormon Pioneer National Historic
- 14 Trail.—Section 5(a)(4) of the National Trails System
- 15 Act (16 U.S.C. 1244(a)(4)) is amended by adding at the
- 16 end the following: "No land or interest in land outside the
- 17 exterior boundaries of any federally administered area
- 18 may be acquired by the Federal Government for the trail
- 19 except with the consent of the owner of the land or interest
- 20 in land. The authority of the Federal Government to ac-
- 21 quire fee title under this paragraph shall be limited to an
- 22 average of not more than ½ mile on either side of the
- 23 trail.".
- 24 (c) Continental Divide National Scenic
- 25 Trail.—Section 5(a)(5) of the National Trails System
- 26 Act (16 U.S.C. 1244(a)(5)) is amended by adding at the

- 1 end the following: "No land or interest in land outside the
- 2 exterior boundaries of any federally administered area
- 3 may be acquired by the Federal Government for the trail
- 4 except with the consent of the owner of the land or interest
- 5 in land. The authority of the Federal Government to ac-
- 6 quire fee title under this paragraph shall be limited to an
- 7 average of not more than ½ mile on either side of the
- 8 trail.".
- 9 (d) Lewis and Clark National Historic
- 10 Trail.—Section 5(a)(6) of the National Trails System
- 11 Act (16 U.S.C. 1244(a)(6)) is amended by adding at the
- 12 end the following: "No land or interest in land outside the
- 13 exterior boundaries of any federally administered area
- 14 may be acquired by the Federal Government for the trail
- 15 except with the consent of the owner of the land or interest
- 16 in land. The authority of the Federal Government to ac-
- 17 quire fee title under this paragraph shall be limited to an
- 18 average of not more than ½ mile on either side of the
- 19 trail.".
- 20 (e) Iditarod National Historic Trail.—Section
- 21 5(a)(7) of the National Trails System Act (16 U.S.C.
- 22 1244(a)(7)) is amended by adding at the end the fol-
- 23 lowing: "No land or interest in land outside the exterior
- 24 boundaries of any federally administered area may be ac-
- 25 quired by the Federal Government for the trail except with

- 1 the consent of the owner of the land or interest in land.
- 2 The authority of the Federal Government to acquire fee
- 3 title under this paragraph shall be limited to an average
- 4 of not more than ½ mile on either side of the trail.".
- 5 (f) NORTH COUNTRY NATIONAL SCENIC TRAIL.—
- 6 Section 5(a)(8) of the National Trails System Act (16
- 7 U.S.C. 1244(a)(8)) is amended by adding at the end the
- 8 following: "No land or interest in land outside the exterior
- 9 boundaries of any federally administered area may be ac-
- 10 quired by the Federal Government for the trail except with
- 11 the consent of the owner of the land or interest in land.".
- 12 (g) ICE AGE NATIONAL SCENIC TRAIL.—Section
- 13 5(a)(10) of the National Trails System Act (16 U.S.C.
- 14 1244(a)(10)) is amended by adding at the end the fol-
- 15 lowing: "No land or interest in land outside the exterior
- 16 boundaries of any federally administered area may be ac-
- 17 quired by the Federal Government for the trail except with
- 18 the consent of the owner of the land or interest in land.".
- 19 (h) POTOMAC HERITAGE NATIONAL SCENIC
- 20 Trail.—Section 5(a)(11) of the National Trails System
- 21 Act (16 U.S.C. 1244(a)(11)) is amended—
- 22 (1) by striking the fourth and fifth sentences;
- 23 and
- 24 (2) by adding at the end the following: "No
- land or interest in land outside the exterior bound-

- 1 aries of any federally administered area may be ac-
- 2 quired by the Federal Government for the trail ex-
- 3 cept with the consent of the owner of the land or in-
- 4 terest in land.".
- 5 (i) NEZ PERCE NATIONAL HISTORIC TRAIL.—Sec-
- 6 tion 5(a)(14) of the National Trails System Act (16
- 7 U.S.C. 1244(a)(14)) is amended—
- 8 (1) by striking the fourth and fifth sentences;
- 9 and
- 10 (2) by adding at the end the following: "No
- land or interest in land outside the exterior bound-
- aries of any federally administered area may be ac-
- 13 quired by the Federal Government for the trail ex-
- cept with the consent of the owner of the land or in-
- terest in land. The authority of the Federal Govern-
- ment to acquire fee title under this paragraph shall
- 17 be limited to an average of not more than  $\frac{1}{4}$  mile
- on either side of the trail.".
- 19 SEC. 3. CONFORMING AMENDMENT.
- 20 Section 10 of the National Trails System Act (16
- 21 U.S.C. 1249) is amended by striking subsection (c) and
- 22 inserting the following:
- 23 "(c) Authorization of Appropriations.—
- 24 "(1) In general.—Except as otherwise pro-
- vided in this Act, there are authorized to be appro-

1	priated such sums as are necessary to implement the
2	provisions of this Act relating to the trails des-
3	ignated by section 5(a).
4	"(2) NATCHEZ TRACE NATIONAL SCENIC
5	TRAIL.—
6	"(A) IN GENERAL.—With respect to the
7	Natchez Trace National Scenic Trail (referred
8	to in this paragraph as the 'trail') designated
9	by section 5(a)(12)—
10	"(i) not more than \$500,000 shall be
11	appropriated for the acquisition of land or
12	interests in land for the trail; and
13	"(ii) not more than \$2,000,000 shall
14	be appropriated for the development of the
15	trail.
16	"(B) Participation by volunteer
17	TRAIL GROUPS.—The administering agency for
18	the trail shall encourage volunteer trail groups
19	to participate in the development of the trail."
