Mr. LYNCH introduced the following bill; which was referred to the Committee on Transportation and Infrastructure, and in addition to the Committees on Homeland Security, and Energy and Commerce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned

## A BILL

To require a joint task force on air travel during and after the COVID–19 Public Health Emergency, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Ensuring Health Safe-  
5 ty in the Skies Act of 2021”.

6 **SEC. 2. DEFINITIONS.**

7 In this Act:

1           (1) **ADVISORY COMMITTEE.**—The term “Advi-  
2           sory Committee” means the Joint Federal Advisory  
3           Committee established under section 4.

4           (2) **AIR TRAVEL.**—The term “air travel” in-  
5           cludes international air travel.

6           (3) **COVID–19 PUBLIC HEALTH EMERGENCY.**—  
7           The term “COVID–19 public health emergency”  
8           means the public health emergency first declared on  
9           January 31, 2020, by the Secretary of Health and  
10          Human Services under section 319 of the Public  
11          Health Service Act (42 U.S.C. 247d) with respect to  
12          COVID–19 and includes any renewal of such dec-  
13          laration pursuant to such section 319.

14          (4) **JOINT TASK FORCE.**—The term “Joint  
15          Task Force” means the Joint Task Force on Air  
16          Travel During and After the COVID–19 Public  
17          Health Emergency established under section 3(a).

18 **SEC. 3. JOINT TASK FORCE ON AIR TRAVEL DURING AND**  
19 **AFTER THE COVID–19 PUBLIC HEALTH EMER-**  
20 **GENCY.**

21          (a) **IN GENERAL.**—Not later than 30 days after the  
22          date of enactment of this Act, the Secretary of Transpor-  
23          tation, the Secretary of Homeland Security, and the Sec-  
24          retary of Health and Human Services shall establish the

1 Joint Task Force on Air Travel During and After the  
2 COVID–19 Public Health Emergency.

3 (b) DUTIES.—

4 (1) IN GENERAL.—The Joint Task Force shall  
5 develop recommended requirements, plans, and  
6 guidelines to address the health, safety, security, and  
7 logistical issues relating to—

8 (A) the continuation of air travel during  
9 the COVID–19 public health emergency; and

10 (B) the resumption of full operations at  
11 airports and increased passenger air travel after  
12 the COVID–19 public health emergency.

13 (2) RECOMMENDATIONS.—The recommenda-  
14 tions developed under paragraph (1), with respect to  
15 the applicable periods described in paragraph (3),  
16 shall include—

17 (A) modifying airport, air carrier, security  
18 (including passenger security screening), and  
19 other operations related to passenger air travel,  
20 including passenger queuing, boarding,  
21 deplaning, and baggage handling procedures, as  
22 a result of—

23 (i) current and anticipated changes to  
24 passenger air travel during and after the  
25 COVID–19 public health emergency; and

1                   (ii) anticipated changes to passenger  
2                   air travel resulting from any seasonal re-  
3                   currence of the coronavirus;

4                   (B) mitigating the public health and eco-  
5                   nomic impacts of the COVID–19 public health  
6                   emergency and any seasonal recurrence of the  
7                   coronavirus on airports and passenger air travel  
8                   (including through the use of personal protec-  
9                   tive equipment, the implementation of strategies  
10                  to promote overall passenger and employee safe-  
11                  ty, and the accommodation of social distancing  
12                  as feasible and necessary);

13                  (C) addressing privacy and civil liberty  
14                  issues that may arise from passenger health  
15                  screenings, contact-tracing, or other processes  
16                  used to monitor the health of individuals en-  
17                  gaged in air travel; and

18                  (D) operating procedures to manage future  
19                  public health crises that can be anticipated, to  
20                  the extent such public health crises may impact  
21                  air travel.

22                  (3) APPLICABLE PERIODS.—For purposes of  
23                  paragraph (2), the applicable periods described in  
24                  this paragraph are the following periods:

1           (A) The period beginning on the date of  
2           the first meeting of the Joint Task Force and  
3           ending on the last day of the COVID–19 public  
4           health emergency.

5           (B) The 1-year period beginning on the  
6           day after the end of the period described in  
7           subparagraph (A).

8           (c) ACTIVITIES OF THE JOINT TASK FORCE.—

9           (1) IN GENERAL.—In developing the rec-  
10          ommended requirements, plans, and guidelines  
11          under subsection (b), and prior to including such  
12          recommendations in the final report required under  
13          section 5(b), the Joint Task Force shall—

14           (A) conduct cost-benefit evaluations re-  
15           garding such recommendations, including costs  
16           impacting air operations and impacts on air  
17           travel;

18           (B) consider funding constraints;

19           (C) use risk-based decision making; and

20           (D) consult with the Advisory Committee  
21           established in section 4(a) and consider any  
22           consensus policy recommendations of the Advi-  
23           sory Committee submitted under section 4(b).

24          (2) INTERNATIONAL CONSULTATION.—The  
25          Joint Task Force shall consult, as practicable, with

1 relevant international entities and operators, includ-  
2 ing the International Civil Aviation Organization, to  
3 harmonize (to the extent possible) recommended re-  
4 quirements, plans, and guidelines for air travel dur-  
5 ing and after the COVID–19 public health emer-  
6 gency.

7 (d) MEMBERSHIP.—

8 (1) CHAIR.—The Secretary of Transportation  
9 (or the Secretary’s designee) shall serve as Chair of  
10 the Joint Task Force.

11 (2) VICE-CHAIR.—The Secretary of Health and  
12 Human Services (or the Secretary’s designee) shall  
13 serve as Vice-Chair of the Joint Task Force.

14 (3) OTHER MEMBERS.—In addition to the  
15 Chair and Vice-Chair, the members of the Joint  
16 Task Force shall include representatives of the fol-  
17 lowing:

18 (A) The Department of Transportation.

19 (B) The Department of Homeland Secu-  
20 rity.

21 (C) The Department of Health and  
22 Human Services.

23 (D) The Federal Aviation Administration.

24 (E) The Transportation Security Adminis-  
25 tration.

1 (F) U.S. Customs and Border Protection.

2 (G) The Centers for Disease Control and  
3 Prevention.

4 (H) The Occupational Safety and Health  
5 Administration.

6 (I) The National Institute for Occupational  
7 Safety and Health.

8 (J) The Pipeline and Hazardous Materials  
9 Safety Administration.

10 (K) The Department of State.

11 (L) The Environmental Protection Agency.

12 **SEC. 4. JOINT FEDERAL ADVISORY COMMITTEE.**

13 (a) ESTABLISHMENT.—Not later than 15 days after  
14 the date on which the Joint Task Force is established  
15 under section 3(a), the Secretary of Transportation, in  
16 consultation with the Secretary of Homeland Security and  
17 the Secretary of Health and Human Services, shall estab-  
18 lish a Joint Federal Advisory Committee to advise the  
19 Joint Task Force.

20 (b) DUTIES OF THE ADVISORY COMMITTEE.—The  
21 Advisory Committee shall develop and submit consensus  
22 policy recommendations to the Joint Task Force for the  
23 Joint Task Force to consider when developing rec-  
24 ommendations under section 3(b).

1 (c) MEMBERSHIP.—The members of the Advisory  
2 Committee shall include representatives of the following:

3 (1) Airport operators designated by the Sec-  
4 retary of Transportation in consultation with the  
5 Secretary of Homeland Security.

6 (2) Air carriers designated by the Secretary of  
7 Transportation.

8 (3) Aircraft and aviation manufacturers des-  
9 igned by the Secretary of Transportation.

10 (4) Labor organizations representing—

11 (A) aviation industry workers (including  
12 pilots, flight attendants, engineers, mainte-  
13 nance, mechanics, air traffic controllers, safety  
14 inspectors, and workers performing airport  
15 services such as security, terminal and cabin  
16 cleaning, passenger assistance, and aircraft  
17 loading) designated by the Secretary of Trans-  
18 portation; and

19 (B) security screening personnel des-  
20 igned by the Secretary of Homeland Security.

21 (5) Public health experts designated by the Sec-  
22 retary of Health and Human Services.

23 (6) Organizations representing airline pas-  
24 sengers designated by the Secretary of Transpor-  
25 tation.



1           (7) Privacy and civil liberty organizations des-  
2           ignated by the Secretary of Homeland Security.

3           (8) Manufacturers and integrators of passenger  
4           screening and identity verification technologies des-  
5           ignated by the Secretary of Homeland Security.

6           (9) Trade associations representing air carriers  
7           (including major passenger air carriers, low-cost  
8           passenger air carriers, regional passenger air car-  
9           riers, cargo air carriers, and foreign passenger air  
10          carriers) designated by the Secretary of Transpor-  
11          tation in consultation with the Secretary of Home-  
12          land Security.

13          (10) Trade associations representing airport op-  
14          erators (including large hub, medium hub, small  
15          hub, nonhub primary, and nonprimary commercial  
16          service airports) designated by the Secretary of  
17          Transportation in consultation with the Secretary of  
18          Homeland Security.

19          (11) Aviation contractors designated by the  
20          Secretary of Transportation.

21          (d) VACANCIES.—Any vacancy in the membership of  
22          the Advisory Committee shall not affect its responsibilities  
23          but shall be filled in the same manner as the original ap-  
24          pointment and in accordance with the Federal Advisory  
25          Committee Act (5 U.S.C. App).

1 (e) PROHIBITION ON COMPENSATION.—The members  
2 of the Advisory Committee shall not receive any compensa-  
3 tion from the Federal Government by reason of their serv-  
4 ice on the Advisory Committee.

5 (f) PUBLICATION.—Not later than 14 days after the  
6 date on which the Advisory Committee submits policy rec-  
7 ommendations to the Joint Task Force pursuant to sub-  
8 section (b), the Secretary of Transportation shall publish  
9 such policy recommendations on a publicly accessible  
10 website.

11 **SEC. 5. BRIEFINGS AND REPORTS.**

12 (a) PRELIMINARY BRIEFINGS.—As soon as prac-  
13 ticable, but not later than 6 months after the date on  
14 which the Joint Task Force is established under section  
15 3(a), the Joint Task Force shall begin providing prelimi-  
16 nary briefings to Congress on the status of the develop-  
17 ment of the recommended requirements, plan, and guide-  
18 lines under section 3(b). The preliminary briefings shall  
19 include interim versions, if any, of the recommendations  
20 of the Joint Task Force.

21 (b) FINAL REPORT.—

22 (1) DEADLINE.—As soon as practicable, but  
23 not later than 18 months after the date of enact-  
24 ment of this Act, the Joint Task Force shall submit  
25 a final report to Congress.

1           (2) CONTENT.—The final report shall include  
2 the following:

3           (A) All of the recommended requirements,  
4 plans, and guidelines developed by the Joint  
5 Task Force under section 3(b), and a descrip-  
6 tion of any action taken by the Federal Govern-  
7 ment as a result of such recommendations.

8           (B) Consensus policy recommendations  
9 submitted by the Advisory Committee under  
10 section 4(b), and an explanation (including data  
11 and risk analysis) of any action by the Joint  
12 Task Force in response to such recommenda-  
13 tions.

14 **SEC. 6. TERMINATION.**

15       The Joint Task Force and the Advisory Committee  
16 shall terminate 30 days after the date on which the Joint  
17 Task Force submits the final report required under sec-  
18 tion 5(b).
