## A BILL

To amend the Omnibus Crime Control and Safe Streets  
Act of 1968 to enhance the safety of America's schools.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “School Safety En-  
5       hancements Act of 2013”.

6       **SEC. 2. GRANT PROGRAM FOR SCHOOL SECURITY.**

7       Section 2701 of title I of the Omnibus Crime Control  
8       and Safe Streets Act of 1968 (42 U.S.C. 3797a) is amend-  
9       ed—

10               (1) in subsection (b)—

1 (A) in paragraph (1)—

2 (i) by striking “Placement” and in-  
3 sserting “Installation”; and

4 (ii) by inserting “surveillance equip-  
5 ment,” after “detectors,”;

6 (B) by redesignating paragraph (5) as  
7 paragraph (6); and

8 (C) by inserting after paragraph (4) the  
9 following:

10 “(5) Establishment of hotlines or tiplines for  
11 the reporting of potentially dangerous students and  
12 situations.”; and

13 (2) by adding at the end the following:

14 “(g) INTERAGENCY TASK FORCE.—

15 “(1) ESTABLISHMENT.—Not later than 60 days  
16 after the date of enactment of this subsection, the  
17 Director, in collaboration with the Secretary of Edu-  
18 cation, shall establish an interagency task force to  
19 develop a set of advisory school safety guidelines.

20 “(2) PUBLICATION OF GUIDELINES.—Not later  
21 than one year after the date of enactment of this  
22 subsection, the interagency task force shall publish  
23 the advisory school safety guidelines developed under  
24 paragraph (1) in the Federal Register.

1           “(3) REQUIRED CONSULTATION.—In developing  
2           the advisory school safety guidelines under para-  
3           graph (1), the interagency task force shall consult  
4           with stakeholders and interested parties, including  
5           parents, teachers, and agencies.

6           “(4) USE OF GUIDELINES.—In determining  
7           permissible uses of funds under subsection (b)(6),  
8           the Director shall consider the advisory school safety  
9           guidelines developed under paragraph (1).”.

10 **SEC. 3. APPLICATIONS.**

11           Section 2702(a)(2) of title I of the Omnibus Crime  
12           Control and Safe Streets Act of 1968 (42 U.S.C.  
13           3797b(a)(2)) is amended to read as follows:

14           “(2) be accompanied by a report—

15                   “(A) signed by the heads of each law en-  
16                   forcement agency and school district with juris-  
17                   diction of the schools where the safety improve-  
18                   ments will be implemented; and

19                   “(B) demonstrating that each proposed use  
20                   of the grant funds will be—

21                           “(i) an effective means for improving  
22                           the safety of one or more schools;

23                           “(ii) consistent with a comprehensive  
24                           approach to preventing school violence; and

1                   “(iii) individualized to the needs of  
2                   each school at which those improvements  
3                   are to be made.”.

4 **SEC. 4. AUTHORIZATION OF APPROPRIATIONS.**

5           Section 2705 of title I of the Omnibus Crime Control  
6 and Safe Streets Act of 1968 (42 U.S.C. 3797e) is amend-  
7 ed—

8                   (1) by striking “\$30,000,000” and inserting  
9                   “\$40,000,000”; and

10                   (2) by striking “2001 through 2009” and in-  
11                   serting “2014 through 2023”.
