Mr. GREEN of Tennessee introduced the following bill; which was referred to the Committee on Agriculture

## A BILL

To direct the Secretary of Agriculture to release certain reversionary interests of the United States in and to a parcel of land located in Henderson, Tennessee.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Chester County Rever-  
5 sionary Interest Release Act”.

6 **SEC. 2. DEFINITIONS.**

7 In this Act:

8 (1) SECRETARY.—The term “Secretary” means  
9 the Secretary of Agriculture.

1           (2) STATE.—The term “State” means the State  
2 of Tennessee.

3           (3) STATE FOREST LAND.—The term “State  
4 forest land” means the approximately 0.62-acre par-  
5 cel of land in Chickasaw State Forest that is identi-  
6 fied as “State Forest Land” on the map prepared  
7 by the Forest Service entitled “State Forest Land  
8 Detail Map” and dated October 9, 2018.

9           (4) WEBB PROPERTY.—The term “Webb prop-  
10 erty” means the approximately 0.90-acre parcel of  
11 land owned by Kirby and Leta Webb identified as  
12 “Webb Property Lot 1” on the map prepared by the  
13 Tennessee Division of Forestry entitled “Webb  
14 Property Detail Map” and dated October 9, 2018.

15 **SEC. 3. RELEASE OF REVERSIONARY INTEREST.**

16           (a) RELEASE.—To facilitate an exchange of land be-  
17 tween the Bethel Baptist Church in Henderson, Ten-  
18 nessee, and the State, the Secretary shall release the re-  
19 versionary interest of the United States in and to the  
20 State forest land described in subsection (b) if, as consid-  
21 eration for the release, the State agrees to transfer to the  
22 United States a vested future interest in and to the Webb  
23 property that is similar to the reversionary interest de-  
24 scribed in subsection (b).

1 (b) DESCRIPTION OF REVERSIONARY INTEREST.—

2 The reversionary interest referred to in subsection (a) is  
3 the reversionary interest of the United States in and to  
4 the State forest land that—

5 (1) requires that the State forest land be used  
6 for public purposes; and

7 (2) is contained in a deed—

8 (A) granting from the United States to the  
9 State the State forest land;

10 (B) dated August 12, 1955; and

11 (C) registered on page 588 of book 48 of  
12 the record of deeds for Chester County, Ten-  
13 nessee.

14 **SEC. 4. SALE OF MINERAL RIGHTS.**

15 (a) IN GENERAL.—Subject to any valid existing  
16 rights of third parties, as soon as practicable after the  
17 date on which the Secretary determines that the State has  
18 complied with the requirements of subsection (b)(2), the  
19 Secretary shall convey to the State the undivided mineral  
20 interests of the United States in and to the State forest  
21 land.

22 (b) TERMS OF CONVEYANCE.—

23 (1) IN GENERAL.—Not later than 90 days after  
24 the date of enactment of this Act, the Secretary  
25 shall determine—

1 (A) the mineral character of the State for-  
2 est land; and

3 (B) the fair market value of the mineral  
4 interests referred to in subsection (a).

5 (2) PAYMENT OF COSTS.—As a condition of the  
6 conveyance under subsection (a), the State shall pay  
7 to the United States—

8 (A) any administrative costs incurred by  
9 the United States in conveying to the State the  
10 mineral interests referred to in subsection (a),  
11 including the costs incurred by the Secretary in  
12 making the determinations required under  
13 paragraph (1); and

14 (B) an amount equal to the fair market  
15 value of the mineral interests referred to in sub-  
16 section (a), as determined under paragraph  
17 (1)(B).
