# **A BILL**

To amend title 18, United States Code, to provide for the protection of community centers with religious affiliation, and for other purposes.

1        *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4        *This Act may be cited as the “Protecting Religiously*  
5 *Affiliated Institutions Act of 2017”.*

6 **SEC. 2. PROTECTION OF COMMUNITY CENTERS WITH RELI-**  
7 **GIUS AFFILIATION.**

8        *Section 247 of title 18, United States Code, is amend-*  
9 *ed—*

10            (1) *in subsection (a)(2), by inserting after*  
11 *“threat of force,” the following: “including by threat*  
12 *of force against religious real property,”;*

13            (2) *in subsection (d)—*

14                    (A) *in paragraph (3), by striking “and” at*  
15 *the end;*

16                    (B) *by redesignating paragraph (4) as*  
17 *paragraph (5); and*

18                    (C) *by inserting after paragraph (3) the fol-*  
19 *lowing:*

20                    “(4) *if damage to or destruction of property re-*  
21 *sults from the acts committed, by means of fire or ex-*  
22 *plosives, in violation of this section, a fine in accord-*  
23 *ance with this title and imprisonment for not more*  
24 *than 3 years, or both; and”;* and

1           (3) in subsection (f), by inserting before the pe-  
2           riod at the end the following: “, or real property  
3           owned or leased by a nonprofit, religiously affiliated  
4           organization”.
