## A BILL

To amend the Reclamation Wastewater and Groundwater Study and Facilities Act to authorize the Secretary of the Interior to participate in the city of Downey, California, regional wastewater treatment and reclamation facility projects.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Downey Regional  
5       Water Reclamation and Groundwater Augmentation  
6       Project of 2009”.

1 **SEC. 2. PROJECT AUTHORIZATION.**

2 (a) IN GENERAL.—The Reclamation Wastewater and  
3 Groundwater Study and Facilities Act (Public Law 102–  
4 575, title XVI; 43 U.S.C. 390h et seq.) is amended by  
5 adding after the last section the following:

6 **“SEC. 16\_\_ . CITY OF DOWNEY REGIONAL WATER REC-**  
7 **LAMATION AND GROUNDWATER AUGMENTA-**  
8 **TION PROJECT, CALIFORNIA.**

9 “(a) AUTHORIZATION.—The Secretary, in coopera-  
10 tion with the city of Downey, California, may participate  
11 in the design, planning, and construction of permanent fa-  
12 cilities needed to establish recycled water distribution and  
13 wastewater treatment and reclamation facilities that will  
14 be used to treat wastewater and provide recycled water  
15 in the cities of Downey Cerritos, Norwalk, Pico Rivera,  
16 South Gate, and Lakewood, California.

17 “(b) COST-SHARING.—The Federal share of the cost  
18 of the project described in subsection (a) shall not exceed  
19 25 percent of the total cost of the project.

20 “(c) LIMITATION.—Funds provided by the Secretary  
21 shall not be used for the operation and maintenance of  
22 the project described in subsection (a).

23 “(d) AUTHORIZATION OF APPROPRIATIONS.—There  
24 is authorized to be appropriated to carry out this section  
25 \$20,000,000.

1       “(e) SUNSET OF AUTHORITY.—This section shall  
2 have no effect after the date that is 10 years after the  
3 date of the enactment of this section.”.

4       (b) CONFORMING AMENDMENT.—The table of sec-  
5 tions in section 2 of Public Law 102–575 is amended by  
6 adding after the last item the following:

“Sec. 16\_\_\_\_. City of Downey regional water reclamation and groundwater  
augmentation project, California.”.
