## **A BILL**

To direct the Secretary of Veterans Affairs to establish a national cemetery for veterans in the southern Colorado region.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. ESTABLISHMENT OF NATIONAL CEMETERY IN
- 4 SOUTHERN COLORADO REGION.
- 5 (a) In General.—The Secretary of Veterans Affairs
- 6 shall establish, in accordance with chapter 24 of title 38,
- 7 United States Code, a national cemetery in El Paso Coun-

- 1 ty, Colorado, to serve the needs of veterans and their fami-
- 2 lies in the southern Colorado region.
- 3 (b) Consultation in Selection of Site.—Before
- 4 selecting the site for the national cemetery established
- 5 under subsection (a), the Secretary shall consult with—
- 6 (1) appropriate officials of the State of Colo-
- 7 rado and local officials in the southern Colorado re-
- 8 gion; and
- 9 (2) appropriate officials of the United States,
- 10 including the Administrator of General Services,
- with respect to land belonging to the United States
- in El Paso County, Colorado, that would be suitable
- to establish the national cemetery under subsection
- 14 (a).
- (c) Authority To Accept Donation of Parcel
- 16 of Land.—
- 17 (1) In General.—The Secretary of Veterans
- 18 Affairs may accept on behalf of the United States
- the gift of an appropriate parcel of real property.
- The Secretary shall have administrative jurisdiction
- 21 over such parcel of real property, and shall use such
- parcel to establish the national cemetery under sub-
- section (a).
- 24 (2) Income tax treatment of gift.—For
- 25 purposes of Federal income, estate, and gift taxes,

- 1 the real property accepted under paragraph (1) shall
- 2 be considered as a gift to the United States.
- 3 (d) Report.—As soon as practicable after the date
- 4 of the enactment of this Act, the Secretary shall submit
- 5 to Congress a report on the establishment of the national
- 6 cemetery under subsection (a). The report shall set forth
- 7 a schedule for such establishment and an estimate of the
- 8 costs associated with such establishment.
- 9 (e) Relationship to Construction and Five
- 10 Year Capital Plan.—The requirement to establish a
- 11 national cemetery under subsection (a) shall be added to
- 12 the current list of priority projects, but should not take
- 13 priority over existing projects listed on the National Ceme-
- 14 tery Administration's construction and five-year capital
- 15 plan for fiscal year 2008.
- 16 (f) SOUTHERN COLORADO REGION DEFINED.—In
- 17 this Act, the term "southern Colorado region" means the
- 18 geographic region consisting of the following Colorado
- 19 counties:
- 20 (1) El Paso.
- 21 (2) Pueblo.
- 22 (3) Teller.
- 23 (4) Fremont.
- 24 (5) Las Animas.
- 25 (6) Huerfano.
