### AN ACT

#### 1 SECTION 1. SHORT TITLE.

2 This Act may be cited as the "Reducing Flight3 Delays Act of 2013".

4 SEC. 2. AUTHORIZATION TO TRANSFER CERTAIN FUNDS TO
5 PREVENT REDUCED OPERATIONS AND
6 STAFFING OF THE FEDERAL AVIATION AD7 MINISTRATION.

8 (a) IN GENERAL.—Notwithstanding division G of the 9 Consolidated and Further Continuing Appropriations Act, 2013 (Public Law 113–6), any other provision of law, or 10 11 a sequestration order issued or to be issued by the President pursuant to section 251A(7)(A) of the Balanced 12 13 Budget and Emergency Deficit Control Act of 1985 (2) U.S.C. 901a(7)(A)), the Secretary of Transportation may 14 transfer during fiscal year 2013 an amount equal to the 15 16 amount specified in subsection (c) to the appropriations accounts providing for the operations of the Federal Avia-17 tion Administration, for any activity or activities funded 18 19 by that account, from—

(1) the amount made available for obligation in
that fiscal year as discretionary grants-in-aid for airports pursuant to section 47117(f) of title 49,
United States Code; or

24 (2) any other program or account of the Fed-25 eral Aviation Administration.

(b) AVAILABILITY AND OBLIGATION OF TRANS FERRED AMOUNTS.—An amount transferred under sub section (a)(1) shall—

4 (1) be available immediately for obligation and
5 expenditure as directly appropriated budget author6 ity; and

7 (2) be deemed as obligated for grants-in-aid for 8 airports under part B of subtitle VII of title 49, 9 United States Code, for purposes of complying with 10 the limitation on incurring obligations during that 11 fiscal year under the heading "GRANTS-IN-AID FOR AIRPORTS" under title I of the Transportation, 12 13 Housing and Urban Development, and Related 14 Agencies Appropriations Act, 2012 (division C of 15 Public Law 112–55; 125 Stat. 647), and made ap-16 plicable to fiscal year 2013 by division F of the Con-17 solidated and Further Continuing Appropriations 18 Act, 2013 (Public Law 113–6).

(c) AMOUNT SPECIFIED.—The amount specified in
this subsection is the amount, not to exceed \$253,000,000,
that the Secretary of Transportation determines to be necessary to prevent reduced operations and staffing of the
Federal Aviation Administration during fiscal year 2013
to ensure a safe and efficient air transportation system;
and provided that none of the funds transferred under this

subsection may be obligated unless the Secretary notifies
 the Committees on Appropriations of the House of Rep resentatives and the Senate at least 5 days in advance of
 such transfer.
