A BILL

To amend chapter 11 of title 31, United States Code, to require the Director of the Office of Management and Budget to annually submit to Congress a report on all disaster-related assistance provided by the Federal Government.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Disclosing Aid Spent
5 to Ensure Relief Act” or the “DISASTER Act”.

6 **SEC. 2. FINDINGS.**

7 Congress finds the following:

8 (1) At a time of constrained budgets, it is fis-
9 cally prudent to understand the amount and the
10 scope of the Federal Government’s involvement in
11 providing disaster-related assistance to communities
12 in need.

13 (2) The Federal Government does not provide
14 a single, publicly available estimate of the amount it
15 is spending on disaster-related assistance.

16 (3) Because recovery is a long-term process,
17 providing disaster-related assistance requires signifi-
18 cant Federal resources to support a multi-agency,
19 multi-year restoration of infrastructure and com-
20 merce in affected communities.

21 (4) Understanding the expenditures of indi-
22 vidual Federal agencies for disaster-related assist-
23 ance will help better inform the congressional appro-
24 priations process, as well as presidential budget re-
25 quests.

1 (5) Knowledge about disaster-related expenses
2 will illustrate opportunities for reducing these ex-
3 penses through efforts to reduce vulnerabilities to
4 future natural disasters.

5 **SEC. 3. PURPOSE.**

6 The purpose of this Act is to require the Director
7 of the Office of Management and Budget to annually sub-
8 mit to Congress a report on all disaster-related assistance
9 provided by the Federal Government.

10 **SEC. 4. REPORTING OF DISASTER-RELATED ASSISTANCE.**

11 (a) IN GENERAL.—Chapter 11 of title 31, United
12 States Code, is amended by adding at the end the fol-
13 lowing new section:

14 **“§ 1127. Reporting of disaster-related assistance**

15 “(a) IN GENERAL.—On the same day that the Presi-
16 dent makes the annual budget submission to the Congress
17 under section 1105(a) for a fiscal year, the Director of
18 the Office of Management and Budget shall submit to
19 Congress a report on Federal disaster-related assistance
20 for the fiscal year ending in the calendar year immediately
21 preceding the calendar year in which the annual budget
22 submission is made. Disaster-related assistance encom-
23 passes Federal obligations related to disaster response, re-
24 covery, and mitigation efforts, as well as administrative

1 costs associated with these activities, including spending
2 by the following agencies and programs:

3 “(1) Department of Agriculture:

4 “(A) Agriculture Research Service.

5 “(B) Farm Service Agency.

6 “(C) Food and Nutrition Service.

7 “(D) Natural Resource Conservation Serv-
8 ice.

9 “(E) Forest Service.

10 “(F) Rural Housing Service.

11 “(G) Rural Utilities Service.

12 “(2) Department of Commerce:

13 “(A) National Marine Fisheries Service of

 - 21 “(6) Response and recovery spending.
 - 22 “(7) Mitigation spending.
 - 23 “(8) Spending in the form of loans.
 - 24 “(9) Spending in the form of grants.

1 “(c) AVAILABILITY OF REPORT.—The report shall be
2 made publicly available on the website of the Office of
3 Management and Budget and should be searchable, sort-
4 able and downloadable.”.

5 (b) CONFORMING AMENDMENT.—The table of chap-
6 ters for chapter 11 of title 31, United States Code, is
7 amended by adding at the end the following new item:
“1127. Reporting of disaster-related assistance.”.

8 **SEC. 5. EFFECTIVE DATE.**

9 The reporting requirement under the amendment
10 made by section 3(a) shall take effect with the budget sub-
11 mission of the President under section 1105(a) of title 31,
12 United States Code, for fiscal year 2022.
