# AN ACT

- To amend chapter 11 of title 31, United States Code, to require the Director of the Office of Management and Budget to annually submit to Congress a report on all disaster-related assistance provided by the Federal Government.
  - 1 Be it enacted by the Senate and House of Representa-
  - ${\it 2\ tives\ of\ the\ United\ States\ of\ America\ in\ Congress\ assembled},$

### 1 SECTION 1. SHORT TITLE.

- This Act may be cited as the "Disclosing Aid Spent
- 3 to Ensure Relief Act" or the "DISASTER Act".

### 4 SEC. 2. FINDINGS.

- 5 Congress finds the following:
- 6 (1) At a time of constrained budgets, it is fis-7 cally prudent to understand the amount and the 8 scope of the Federal Government's involvement in 9 providing disaster-related assistance to communities
- in need.

- 12 (2) The Federal Government does not provide 12 a single, publicly available estimate of the amount it 13 is spending on disaster-related assistance.
  - (3) Because recovery is a long-term process, providing disaster-related assistance requires significant Federal resources to support a multi-agency, multi-year restoration of infrastructure and commerce in affected communities.
  - (4) Understanding the expenditures of individual Federal agencies for disaster-related assistance will help better inform the congressional appropriations process, as well as presidential budget requests.
- 24 (5) Knowledge about disaster-related expenses 25 will illustrate opportunities for reducing these ex-

- 1 penses through efforts to reduce vulnerabilities to
- 2 future natural disasters.

### 3 SEC. 3. PURPOSE.

- 4 The purpose of this Act is to require the Director
- 5 of the Office of Management and Budget to annually sub-
- 6 mit to Congress a report on all disaster-related assistance
- 7 provided by the Federal Government.

### 8 SEC. 4. REPORTING OF DISASTER-RELATED ASSISTANCE.

- 9 (a) In General.—Chapter 11 of title 31, United
- 10 States Code, is amended by adding at the end the fol-
- 11 lowing new section:

## 12 "§ 1127. Reporting of disaster-related assistance

- "(a) IN GENERAL.—On the same day that the Presi-
- 14 dent makes the annual budget submission to the Congress
- 15 under section 1105(a) for a fiscal year, the Director of
- 16 the Office of Management and Budget shall submit to
- 17 Congress a report on Federal disaster-related assistance
- 18 for the fiscal year ending in the calendar year immediately
- 19 preceding the calendar year in which the annual budget
- 20 submission is made. Disaster-related assistance encom-
- 21 passes Federal obligations related to disaster response, re-
- 22 covery, and mitigation efforts, as well as administrative
- 23 costs associated with these activities, including spending
- 24 by the following agencies and programs:

- 1 (b) Conforming Amendment.—The table of chap-
- 2 ters for chapter 11 of title 31, United States Code, is
- 3 amended by adding at the end the following new item: "1127. Reporting of disaster-related assistance.".

### 4 SEC. 5. EFFECTIVE DATE.

- 5 The reporting requirement under the amendment
- 6 made by section 3(a) shall take effect with the budget sub-
- 7 mission of the President under section 1105(a) of title 31,
- 8 United States Code, for fiscal year 2022.
