A BILL

- To authorize the Marine Mammal Commission to establish a national research program to fund basic and applied research on marine mammals, and for other purposes.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,

3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the "National Marine Mam-

5 mal Research Program Act of 2009".

6 SEC. 2. FINDINGS.

- 7 Congress finds that—
- 8 (1) populations of marine mammals that occur9 in waters of the United States are resources of sub-

stantial ecological, scientific, socioeconomic, and es thetic value;
 (2) although progress has been made toward
 understanding the impacts of human activities and
 natural environmental changes on marine mammal
 populations, much work remains to be done;

7 (3) some marine mammal populations are in
8 various stages of recovery, while many others remain
9 critically endangered and their status has not im10 proved or has declined;

(4) there is a clear need to better understand,
evaluate, and mitigate the impacts on marine mammals and other marine species of an array of anthropogenic activities;

(5) data gaps and scientific uncertainty present
resource managers with significant challenges in implementing the Marine Mammal Protection Act of
1972 (16 U.S.C. 1361 et seq.) the Endangered Species Act of 1973 (16 U.S.C. 1531 et seq.), and the
National Environmental Policy Act of 1969 (42
U.S.C. 4321 et seq.);

(6) funding has been insufficient to support all
of the research required to fully understand and
properly conserve and manage marine mammal populations;

1 (7) in particular, in a recent report to Congress 2 the Marine Mammal Commission recommended the 3 establishment of a research program, the initial goal 4 of which is to improve understanding of anthropo-5 genic sound, its biologically significant effects on 6 marine mammals and marine ecosystems, and effec-7 tive means for mitigating and monitoring those ef-8 fects;

9 (8) understanding marine mammals through re-10 search is essential for using the oceans wisely and 11 protecting marine living resources, and the United 12 States should maintain its world leadership in ma-13 rine mammal science and oceanography as one key 14 to its competitive future; and

(9) the Marine Mammal Commission established under section 201 of the Marine Mammal
Protection Act of 1972 (16 U.S.C. 1401) has research and management responsibilities under that
Act that make it the appropriate entity to administer a marine mammal research program.

21 SEC. 3. NATIONAL MARINE MAMMAL RESEARCH PROGRAM.

(a) ESTABLISHMENT OF PROGRAM.—Title II of the
Marine Mammal Protection Act of 1972 (16 U.S.C. 1401
et seq.) is amended—

1 (1) by inserting after the title heading the fol-2 lowing: "Subtitle A—General Provisions"; 3 4 and (2) by adding at the end the following: 5 "Subtitle B—Marine Mammal 6 Research 7 8 "SEC. 221. NATIONAL MARINE MAMMAL RESEARCH PRO-9 GRAM. "(a) ESTABLISHMENT.—The Commission shall es-10 11 tablish a program to be known as the 'National Marine 12 Mammal Research Program'. "(b) PURPOSES.—The purposes of the program are 13 as follows: 14 "(1) To undertake research to improve the Na-15 16 tion's understanding of marine mammals, the fac-17 tors, natural and human related, that affect and 18 threaten the health of their populations and habi-19 tats, and the means of mitigating those effects to 20 ensure marine mammal conservation. "(2) To coordinate and strengthen scientific re-21 22 search efforts in support of those goals by-"(A) identifying and developing partner-23 24 ships among Federal agencies, academia, indus-25 try, and other members of the oceanographic

2	the areas of data collection, research, resource

4	tion; and
5	"(B) reporting annually to Congress on the
6	program.
7	"(c) DUTIES.—The Commission shall—
8	"(1) prescribe such policies and procedures nec-
9	essary to implement the Research Program;
10	"(2) implement and support the Research Co-
11	ordinating Committee, established under section
12	222;
13	"(3) supervise the performance of duties by the
14	Program Office established under subsection (d);
15	"(4) prepare an annual report to Congress on
16	research undertaken and benefits thereof; and
17	"(5) conduct periodic program reviews.
18	"(d) AUTHORITIES.—The Commission shall have the
19	authority, within the limits of available appropriations, to
20	do all things necessary to carry out the provisions of this
21	section, including the authority to—
22	"(1) enter into contracts, make grants, or enter
23	other arrangements as may be necessary for the pur-
24	pose of implementing the Research Program and
25	carrying out the responsibilities of the Research Co-

19	"(3) prescribe such rules and regulations as it
20	determines necessary governing the operation and
21	organization of the Research Program.
22	"(e) National Marine Mammal Research Pro-

24	"(1) Establishment.—The Commission shall

2	mission shall use competitive procedures in selecting
3	an operator for the Program Office.
4	"(2) DUTIES.—The Commission shall assign
5	the following duties to the Program Office:
6	"(A) Work with the Commission and the
7	Research Coordinating Committee to draft the
8	program announcement, identify proposal selec-
9	tion criteria, organize and conduct an inde-
10	pendent peer review of the proposals, and rec-
11	ommend to the Commission and Research Co-
12	ordinating Committee projects and funding allo-
13	cations for implementation under the Research
14	Program.
15	"(B) Manage the process for soliciting pro-
16	posals for research, including managing peer re-
17	view of such projects, subject to oversight and
18	approval by the Commission and the Research
19	Coordinating Committee.
20	"(C) Submit an annual report on the sta-
21	tus of all projects and activities of the office,
22	for review by the Research Coordinating Com-
23	mittee and final approval and release by the
24	Commission.

1	"(D) Undertake any additional duties for
2	the administration of the Research Program
3	that the Commission or the Research Coordi-
4	nating Committee considers appropriate.
5	"(f) ANNUAL REPORT.—The Commission shall trans-
6	mit to Congress an annual report on progress made in
7	implementing this subtitle. The report shall contain the
8	following:
9	"(1) A description of activities of the Research
10	Program carried out during the preceding fiscal
11	year, with a list of the members of the Research Co-
12	ordinating Committee and any subcommittees in ex-
13	istence during the fiscal year.
14	"(2) A general outline of the activities planned
15	or conducted for the Research Program during the
16	fiscal year for which the report is prepared.
17	"(3) A description of the involvement of the Re-
18	search Program with Federal interagency coordi-
19	nating entities.
20	"(4) The programs, projects, and activities of
21	the Research Program and the estimated expendi-
22	tures under such programs, projects, and activities
23	during the subsequent fiscal year.

2	ORDINATING COMMITTEE.
3	"(a) Committee.—The President, after consultation
4	with the Commission, shall create a National Marine
5	Mammal Research Coordinating Committee.
6	"(b) Membership.—
7	"(1) IN GENERAL.—The Research Coordinating
8	Committee shall be composed of representatives of
9	the following with experience relevant to the pur-
10	poses of this subtitle:
11	"(A) The Secretary of the Navy.
12	"(B) The Administrator of the National
13	Oceanic and Atmospheric Administration.
14	"(C) The Director of the National Science
15	Foundation.
16	"(D) The Administrator of the National
17	Aeronautics and Space Administration.
18	"(E) The Administrator of the Environ-
19	mental Protection Agency.
20	"(F) The Commandant of the Coast
21	Guard.
22	"(G) The Director of the United States
23	Fish and Wildlife Service.
24	"(H) The Director of the United States
25	Geological Survey.

1	"(I) The Director of the Minerals Manage-
2	ment Service.
3	"(J) The President of the National Acad-
4	emy of Sciences.
5	"(K) The Director of the Office of Science
6	and Technology Policy.
7	"(L) The Director of the Office of Man-
8	agement and Budget.
9	"(M) The Executive Director of the Com-
10	mission.
11	"(N) One member appointed by the Re-
12	search Coordinating Committee from among in-
13	dividuals who will represent the views of ocean
14	industries with expertise in marine mammal bi-
15	ology, marine ecology, oceanography, or marine
16	policy.
17	"(O) One member appointed by the Re-
18	search Coordinating Committee from among in-
19	dividuals who will represent the views of State
20	governments with expertise in marine mammal
21	biology, marine ecology, oceanography, or ma-
22	rine policy.
23	"(P) One member appointed by the Re-
24	search Coordinating Committee from among in-
25	dividuals who will represent the views of aca-

1	demia with expertise in marine mammal biol-
2	ogy, marine ecology, oceanography, or marine
3	policy.
4	"(Q) One member appointed by the Re-
5	search Coordinating Committee from among in-
6	dividuals who will represent the views of the
7	marine conservation community with expertise
8	in marine mammal biology, marine ecology,
9	oceanography, or marine policy.
10	"(R) One member appointed by the Re-
11	search Coordinating Committee from among in-
12	dividuals who will represent such other views as
13	the chairman of such committee considers ap-
14	propriate.
15	"(2) FACA.—The Federal Advisory Committee
16	Act (5 App. U.S.C.) shall not apply to the Research
17	Coordinating Committee.
18	"(3) Limitation on service on committee
19	OF SCIENTIFIC ADVISORS ON MARINE MAMMALS.—A
20	member of the Research Coordinating Committee
21	may not simultaneously serve as a member of the
22	Committee of Scientific Advisors on Marine Mam-
23	mals established under section 203.
24	"(c) Chairman and Vice Chairman.—The Execu-
25	tive Director of the Marine Mammal Commission shall be

the chairman of the Research Coordinating Committee 1 2 and the Administrator of the National Oceanic and At-3 mospheric Administration shall be the vice chairman of 4 the Research Coordinating Committee. The chairman may 5 create subcommittees chaired by the representative of any member agency of the Research Coordinating Committee 6 7 to, among other tasks, receive advice, input, or comments 8 from experts on the national marine mammal research 9 plan developed under section 223.

10 "(d) TERM OF OFFICE.—The term of office of a 11 member of the Research Coordinating Committee ap-12 pointed under subparagraph (N), (O), (P), (Q), or (R) of 13 subsection (b)(1) shall be 3 years, except that any member 14 appointed to fill a vacancy occurring before the expiration 15 of the term for which the member's predecessor was ap-16 pointed shall be appointed for the remainder of such term.

17 "(e) RESPONSIBILITIES.—The Research Coordi-18 nating Committee shall have the following responsibilities:

19 "(1) Develop a national marine mammal re-20 search plan under section 223.

21 "(2) Facilitate cooperation among Federal
22 agencies and departments with respect to marine
23 mammal research.

1	"(3) Revise as necessary and approve the pro-
2	gram announcement developed by the Program Of-
3	fice.
4	"(4) Estimate, to the extent practicable, Fed-
5	eral funding needed for marine mammal research ac-
6	tivities to be conducted under the Plan.
7	((5) Review and revise, at a minimum every 3
8	years or as necessary the marine mammal research
9	plan.
10	"(f) Contract and Grant Authority.—
11	"(1) IN GENERAL.—The Federal departments
12	and agencies involved in the Research Coordinating
13	Committee may participate in interagency financing
14	and share, transfer, receive, obligate, and expend
15	funds appropriated to any Federal participant on
16	the Research Coordinating Committee for the pur-
17	poses of carrying out any administrative or pro-
18	grammatic project or activity under this subtitle, in-
19	cluding support for the Program Office and the Re-
20	search Program. Funds may be transferred among
21	such departments and agencies through an appro-
22	priate instrument that specifies the goods, services,
23	or space being acquired from another Research Co-
24	ordinating Committee member and the costs of the
25	same.

"(2) VOLUNTEERS AND GIFTS, DEVISES, AND
 BEQUESTS.—For the purposes of carrying out this
 subtitle the Commission may accept, solicit, and use
 the services of volunteers, and may accept, solicit,
 receive, hold, administer, and use gifts, devises, and
 bequests.

7 "(g) NATIONAL RESEARCH COUNCIL EVALUATION.— 8 The chairman of the Research Coordinating Committee 9 shall seek to enter into an agreement with the National Research Council under which the National Research 10 Council shall periodically evaluate the scientific content of 11 12 the Plan and the implementation of the research con-13 ducted under the Research Program and provide information and advice obtained from United States and inter-14 15 national sources and recommendations for priorities for future marine mammal research. 16

17 "(h) PUBLIC PARTICIPATION.—The Executive Direc18 tor of the Commission shall publish the Plan, and any re19 vision thereof, in the Federal Register for a public com20 ment period of not less than 60 days.

21 "SEC. 223. NATIONAL MARINE MAMMAL RESEARCH PLAN.

22 "The Research Coordinating Committee shall develop
23 within one year after the date of enactment of this subtitle
24 a comprehensive 5-year national marine mammal research
25 plan to—
