# H. R. 2139

---

## AN ACT

To require the Secretary of the Treasury to mint coins  
in commemoration of the centennial of the establishment  
of Lions Clubs International.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Lions Clubs Inter-  
3 national Century of Service Commemorative Coin Act”.

4 **SEC. 2. FINDINGS.**

5 The Congress finds as follows:

6 (1) Lions Clubs International is the world’s  
7 largest service club organization founded in 1917 by  
8 Chicago business leader Melvin Jones. Lions Clubs  
9 International empowers volunteers to serve their  
10 communities, meet humanitarian needs, encourage  
11 peace and promote international understanding  
12 through Lions clubs.

13 (2) Today, Lions Clubs International has over  
14 1.35 million members in more than 45,000 clubs  
15 globally, extending its mission of service throughout  
16 the world every day.

17 (3) In 1945, Lions Clubs International became  
18 one of the first nongovernmental organizations in-  
19 vited to assist in drafting the United Nations Char-  
20 ter and has enjoyed a special relationship with the  
21 United Nations ever since.

22 (4) In 1968, Lions Clubs International Founda-  
23 tion was established to assist with global and large-  
24 scale local humanitarian projects and has since then  
25 awarded more than \$700 million to fund five unique  
26 areas of service: preserving sight, combating dis-

1 ability, promoting health, serving youth and pro-  
2 viding disaster relief.

3 (5) In 1990, the Lions Clubs International  
4 Foundation launched the SightFirst program to  
5 build comprehensive eye care systems to fight the  
6 major causes of blindness and care for the blind or  
7 visually impaired. Thanks to the generosity of Lions  
8 worldwide, over \$415 million has been raised, result-  
9 ing in the prevention of serious vision loss in 30 mil-  
10 lion people and improved eye care for hundreds of  
11 millions of people.

12 (6) On June 7, 2017, Lions Clubs International  
13 will celebrate 100 years of community service to  
14 men, women, and children in need throughout the  
15 world.

16 **SEC. 3. COIN SPECIFICATIONS.**

17 (a) \$1 SILVER COINS.—The Secretary of the Treas-  
18 ury (hereafter in this Act referred to as the “Secretary”)  
19 shall mint and issue not more than 400,000 \$1 coins in  
20 commemoration of the centennial of the founding of the  
21 Lions Clubs International, each of which shall—

22 (1) weigh 26.73 grams;

23 (2) have a diameter of 1.500 inches; and

24 (3) contain 90 percent silver and 10 percent  
25 copper.

1 (b) LEGAL TENDER.—The coins minted under this  
2 Act shall be legal tender, as provided in section 5103 of  
3 title 31, United States Code.

4 (c) NUMISMATIC ITEMS.—For purposes of sections  
5 5134 and 5136 of title 31, United States Code, all coins  
6 minted under this Act shall be considered to be numis-  
7 matic items.

8 **SEC. 4. DESIGN OF COINS.**

9 (a) DESIGN REQUIREMENTS.—

10 (1) IN GENERAL.—The design of the coins  
11 minted under this Act shall be emblematic of the  
12 centennial of the Lions Clubs International.

13 (2) DESIGNATION AND INSCRIPTIONS.—On  
14 each coin minted under this Act, there shall be—

15 (A) a designation of the value of the coin;

16 (B) an inscription of the year “2017”; and

17 (C) inscriptions of the words “Liberty”,

18 “In God We Trust”, “United States of Amer-

19 ica”, and “E Pluribus Unum”.

20 (b) SELECTION.—The design for the coins minted  
21 under this Act shall be—

22 (1) chosen by the Secretary after consultation  
23 with Lions Clubs International Special Centennial  
24 Planning Committee and the Commission of Fine  
25 Arts; and

1           (2) reviewed by the Citizens Coinage Advisory  
2           Committee.

3 **SEC. 5. ISSUANCE OF COINS.**

4           (a) **QUALITY OF COINS.**—Coins minted under this  
5 Act shall be issued in uncirculated and proof qualities.

6           (b) **MINT FACILITY.**—Only one facility of the United  
7 States Mint may be used to strike any particular quality  
8 of the coins minted under this Act.

9           (c) **PERIOD FOR ISSUANCE.**—The Secretary may  
10 issue coins under this Act only during the calendar year  
11 beginning on January 1, 2017.

12 **SEC. 6. SALE OF COINS.**

13           (a) **SALE PRICE.**—The coins issued under this Act  
14 shall be sold by the Secretary at a price equal to the sum  
15 of—

16                   (1) the face value of the coins;

17                   (2) the surcharge provided in section 7 with re-  
18 spect to such coins; and

19                   (3) the cost of designing and issuing the coins  
20 (including labor, materials, dies, use of machinery,  
21 overhead expenses, marketing, and shipping).

22           (b) **BULK SALES.**—The Secretary shall make bulk  
23 sales of the coins issued under this Act at a reasonable  
24 discount.

25           (c) **PREPAID ORDERS.**—

1           (1) IN GENERAL.—The Secretary shall accept  
2           prepaid orders for the coins minted under this Act  
3           before the issuance of such coins.

4           (2) DISCOUNT.—Sale prices with respect to pre-  
5           paid orders under paragraph (1) shall be at a rea-  
6           sonable discount.

7 **SEC. 7. SURCHARGES.**

8           (a) IN GENERAL.—All sales of coins issued under this  
9           Act shall include a surcharge of \$10 per coin.

10          (b) DISTRIBUTION.—Subject to section 5134(f) of  
11          title 31, United States Code, all surcharges received by  
12          the Secretary from the sale of coins issued under this Act  
13          shall be promptly paid by the Secretary to the Lions Clubs  
14          International Foundation for the purposes of—

15                (1) furthering its programs for the blind and  
16                visually impaired in the United States and abroad;

17                (2) investing in adaptive technologies for the  
18                disabled; and

19                (3) investing in youth and those affected by a  
20                major disaster.

21          (c) AUDITS.—The Lions Clubs International Founda-  
22          tion shall be subject to the audit requirements of section  
23          5134(f)(2) of title 31, United States Code, with regard  
24          to the amounts received under subsection (b).

1 (d) LIMITATION.—Notwithstanding subsection (a),  
2 no surcharge may be included with respect to the issuance  
3 under this Act of any coin during a calendar year if, as  
4 of the time of such issuance, the issuance of such coin  
5 would result in the number of commemorative coin pro-  
6 grams issued during such year to exceed the annual 2  
7 commemorative coin program issuance limitation under  
8 section 5112(m)(1) of title 31, United States Code. The  
9 Secretary may issue guidance to carry out this subsection.

10 **SEC. 8. FINANCIAL ASSURANCES.**

11 The Secretary shall take such actions as may be nec-  
12 essary to ensure that—

13 (1) minting and issuing coins under this Act  
14 will not result in any net cost to the United States  
15 Government; and

16 (2) no funds, including applicable surcharges,  
17 shall be disbursed to any recipient designated in sec-  
18 tion 7 until the total cost of designing and issuing  
19 all of the coins authorized by this Act (including  
20 labor, materials, dies, use of machinery, overhead ex-  
21 penses, marketing, and shipping) is recovered by the  
22 United States Treasury, consistent with sections  
23 5112(m) and 5134(f) of title 31, United States  
24 Code.

1 **SEC. 9. BUDGET COMPLIANCE.**

2       The budgetary effects of this Act, for the purpose of  
3 complying with the Statutory Pay-As-You-Go Act of 2010,  
4 shall be determined by reference to the latest statement  
5 titled “Budgetary Effects of PAYGO Legislation” for this  
6 Act, submitted for printing in the Congressional Record  
7 by the Chairman of the Committee on the Budget of the  
8 House of Representatives, provided that such statement  
9 has been submitted prior to the vote on passage.
