Mrs. MILLER of Michigan (for herself, Mr. HUIZENGA of Michigan, Ms. SLAUGHTER, Mr. HIGGINS, Mr. BENISHEK, and Mr. ROGERS of Michigan) introduced the following bill; which was referred to the Committee on Transportation and Infrastructure

A BILL

To implement a program establishing the Great Lakes
Navigation System, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Great Lakes Naviga-
5 tion System Sustainability Act of 2013”.

6 **SEC. 2. DEFINITIONS.**

7 In this Act the term—

8 (1) “Great Lakes” and “Great Lakes Naviga-
9 tional System” means—

- 1 (A)(i) Lake Superior;
- 2 (ii) Lake Huron;
- 3 (iii) Lake Michigan;
- 4 (iv) Lake Erie; and
- 5 (v) Lake Ontario;
- 6 (B) all connecting waters between the
- 7 lakes referred to in subparagraph (A) used for
- 8 commercial and recreational navigation;
- 9 (C) any navigation features in the lakes re-
- 10 ferred to in subparagraph (A) or waters de-
- 11 scribed in subparagraph (B) that are a Federal
- 12 operation or maintenance responsibility; and
- 13 (D) areas of the Saint Lawrence River
- 14 that are operated or maintained by the Govern-
- 15 ment for commercial navigation.
- 16 (2) “eligible operations and maintenance” has
- 17 the same meaning as that term is defined in section
- 18 214 of the Water Resources Development Act of
- 19 1986 (33 U.S.C. 2241);
- 20 (3) “Secretary” means the Secretary of the
- 21 Army.

22 **SEC. 3. GREAT LAKES NAVIGATION SYSTEM.**

- 23 (a) MANAGEMENT OF GREAT LAKES NAVIGATION
- 24 SYSTEM.—To sustain the most effective and efficient op-
- 25 eration and maintenance of the Great Lakes Navigation

1 System, the Secretary, acting through the Chief of Engi-
2 neers, shall manage and allocate funding for all of the in-
3 dividually authorized commercial and recreational nava-
4 gation projects in the Great Lakes Navigation System as
5 components of a single, comprehensive system, recognizing
6 the interdependence of the projects.

7 (b) CARGO MEASUREMENTS.—Cargo measurements
8 for the purpose of prioritizing annual operations and
9 maintenance budget resources for the Great Lakes Navi-
10 gation System, and for any of the component projects of
11 the System, shall aggregate the tonnage of all components
12 of the System.

13 **SEC. 4. GREAT LAKES SYSTEM SUSTAINABILITY.**

14 (a) IN GENERAL.—The Secretary, acting through the
15 Chief of Engineers, shall establish a program to fund eligi-
16 ble operations and maintenance projects of the Great
17 Lakes Navigation System with the objective of maintain-
18 ing such projects to their authorized depths and widths.

19 (b) CONSULTATION.—The Secretary shall consult
20 with the Congressional delegations from States that bor-
21 der the Great Lakes in developing annual priorities for
22 the apportionment of funding authorized to be appro-
23 priated pursuant to this section.

24 (c) AUTHORIZATION OF APPROPRIATIONS.—For each
25 of fiscal years 2014 through 2023, there is authorized to

1 be appropriated from the Harbor Maintenance Trust
2 Fund established by section 9505 of the Internal Revenue
3 Code \$200,000,000 to fund eligible operations and main-
4 tenance of the Great Lakes Navigation System. Funds ap-
5 propriated pursuant to this section may remain available
6 until expended.

7 (d) COST SHARE.—

8 (1) IN GENERAL.—Of the amounts made avail-
9 able pursuant to subsection (c), the Secretary, act-
10 ing through the Chief of Engineers, shall give a
11 higher priority to projects described in paragraph
12 (2) than to projects described in paragraph (3).

13 (2) CERTAIN HARBORS PROVIDING A COST
14 SHARE.—

15 (A) NOT SUBJECT TO HARBOR MAINTE-
16 NANCE FEE.—A Great Lakes Navigation Sys-
17 tem project that is not subject to the harbor
18 maintenance fee under section 24.24 of title 19,
19 Code of Federal Regulations (or successor regu-
20 lations) and for which the non-Federal sponsor
21 provides a cost share of 50 percent of the costs
22 of eligible operations and maintenance expenses,
23 is eligible for Federal operations and mainte-
24 nance funds made available pursuant to sub-
25 section (c).

1 (B) SUBJECT TO HARBOR MAINTENANCE
2 TRUST FUND BUT NO CARGO.—A Great Lakes
3 Navigation System project that is subject to the
4 harbor maintenance fee under section 24.24 of
5 title 19, Code of Federal Regulations (or suc-
6 cessor regulations), has not had commercial
7 cargo loaded or unloaded from its harbor dur-
8 ing the previous 2 fiscal years, and for which
9 the non-Federal sponsor provides a cost share
10 of 50 percent of the costs of eligible operations
11 and maintenance expenses is eligible for Fed-
12 eral operations and maintenance funds made
13 available pursuant to subsection (c).

14 (3) CERTAIN HARBORS WITH NO COST
15 SHARE.—A Great Lakes Navigation System project
16 that otherwise meets the description in subpara-
17 graphs (A) or (B) of paragraph (2), and for which
18 the non-Federal sponsor of the project does not pro-
19 vide a cost share of 50 percent of the costs of eligi-
20 ble operations and maintenance expenses, is eligible
21 to receive Federal operations and maintenance funds
22 made available pursuant to subsection (c) after
23 projects under such subparagraphs are funded.
