A BILL

To require the Director of National Intelligence to conduct a study on the use of contractors for intelligence activities, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Civilian Contractors
5 Engaged in Intelligence Activities Reduction Act of 2013”.

1 **SEC. 2. DIRECTOR OF NATIONAL INTELLIGENCE STUDY ON**
2 **THE USE OF CONTRACTORS IN THE CONDUCT**
3 **OF INTELLIGENCE ACTIVITIES.**

4 (a) **STUDY.**—The Director of National Intelligence
5 shall conduct a study to ascertain the extent to which con-
6 tractors are used in the conduct of intelligence activities
7 and the type of information to which such contractors are
8 exposed or have access.

9 (b) **REPORT.**—Not later than December 31, 2013,
10 the Director of Intelligence shall submit to Congress a re-
11 port containing—

12 (1) the results of the study conducted under
13 subsection (a); and

14 (2) a plan for reducing by 25 percent the num-
15 ber of contractors to the intelligence community with
16 top secret security clearances that are engaged in in-
17 telligence activities (including intelligence analysis).

18 (c) **REDUCTION OF CONTRACTORS.**—Not later than
19 December 31, 2014, the Director of National Intelligence
20 shall reduce the number of contractors to the intelligence
21 community with top secret security clearances that are en-
22 gaged in intelligence activities (including intelligence anal-
23 ysis) as of the date of the enactment of this Act by 25
24 percent.

25 (d) **INTELLIGENCE COMMUNITY DEFINED.**—In this
26 section, the term “intelligence community” has the mean-

1 ing given the term in section 3(4) of the National Security
2 Act of 1947 (50 U.S.C. 3003(4)).
