A BILL

To amend the Public Health Service Act to reauthorize the program of payments to teaching health centers that operate graduate medical education programs.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Doctors of Community
5 Act” or the “DOC Act”.

1 **SEC. 2. REAUTHORIZATION OF PROGRAM OF PAYMENTS TO**
2 **TEACHING HEALTH CENTERS THAT OPERATE**
3 **GRADUATE MEDICAL EDUCATION PRO-**
4 **GRAMS.**

5 Section 340H(g) of the Public Health Service Act (42
6 U.S.C. 256H(g)) is amended—

7 (1) by amending paragraph (1) to read as fol-
8 lows:

9 “(1) IN GENERAL.—To carry out this section,
10 there are appropriated, to remain available until ex-
11 pended, such sums as may be necessary, not to ex-
12 ceed—

13 “(A) \$230,000,000, for the period of fiscal
14 years 2011 through 2015;

15 “(B) \$60,000,000 for each of fiscal years
16 2016 and 2017;

17 “(C) \$126,500,000 for each of fiscal years
18 2018 through 2023;

19 “(D) \$277,200,000 for fiscal year 2024;

20 “(E) \$378,400,000 for fiscal year 2025;

21 “(F) \$445,600,000 for fiscal year 2026;

22 “(G) \$448,000,000 for fiscal year 2027;

23 “(H) \$502,600,000 for fiscal year 2028;

24 “(I) \$517,700,000 for fiscal year 2029;

25 “(J) \$533,300,000 for fiscal year 2030;

26 “(K) \$549,300,000 for fiscal year 2031;

1 “(L) \$565,700,000 for fiscal year 2032;

2 “(M) \$582,700,000 for fiscal year 2033;

3 and

4 “(N) for fiscal year 2034 and each fiscal
5 year thereafter, the dollar amount applicable
6 under this paragraph for the preceding fiscal
7 year, adjusted in accordance with paragraph
8 (3).”; and

9 (2) by adding at the end the following:

10 “(3) ADJUSTMENT FOR INFLATION.—For pur-
11 poses of paragraph (1)(N), the dollar amount appli-
12 cable under paragraph (1) for fiscal years beginning
13 after fiscal year 2033 shall be equal to the dollar
14 amount applicable for the preceding fiscal year, in-
15 creased by the percentage increase in the medical
16 care component of the consumer price index for all
17 urban consumers (U.S. city average), as such per-
18 centage increase is estimated by the Secretary for
19 the 12-month period ending with March of the pre-
20 vious year.”.
