# **A BILL**

To amend the Veterans Access, Choice, and Accountability Act of 2014 to improve the access of veterans to organ transplants, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Veterans Increased*  
5 *Choice for Transplanted Organs and Recovery Act of 2017”*  
6 *or the “VICTOR Act of 2017”.*

7 **SEC. 2. ORGAN TRANSPLANTS UNDER THE VETERANS**  
8 **CHOICE PROGRAM.**

9 *Section 101(b)(2) of the Veterans Access, Choice, and*  
10 *Accountability Act of 2014 (Public Law 113–146; 38 U.S.C.*  
11 *1701 note) is amended—*

12 *(1) in subparagraph (C)(ii), by striking “or”;*

13 *(2) in subparagraph (D)(ii)(II)(dd), by striking*  
14 *the period and inserting “; or”; and*

15 *(3) by adding at the end the following new sub-*  
16 *paragraph:*

17 *“(E)(i) requires an organ or bone marrow*  
18 *transplant; and*

19 *“(ii)(I) has, in the opinion of the primary*  
20 *health care provider of the veteran, a medically*  
21 *compelling reason to travel outside the region of*  
22 *the Organ Procurement and Transplantation*  
23 *Network, established under section 372 of the Na-*  
24 *tional Organ Transplantation Act (Public Law*  
25 *98–507; 42 U.S.C. 274), in which the veteran re-*

1 *sides to receive such transplant at a medical fa-*  
2 *cility of the Department; or*

3 *“(II) faces an unusual or excessive burden*  
4 *in receiving such transplant at a medical facil-*  
5 *ity of the Department, including—*

6 *“(aa) geographical challenges;*

7 *“(bb) environmental factors, including*  
8 *roads that are not accessible to the general*  
9 *public, traffic, or hazardous weather;*

10 *“(cc) a medical condition of the vet-*  
11 *eran that affects the ability to travel; or*

12 *“(dd) other factors the Secretary deter-*  
13 *mines appropriate, including the preference*  
14 *of the veteran to receive such transplant at*  
15 *a non-Department facility.”.*

16 **SEC. 3. EFFECTIVE DATE.**

17 *The amendments made by this Act shall take effect on*  
18 *the later of—*

19 *(1) October 1, 2018; and*

20 *(2) the date of the enactment of this Act.*
