## AN ACT

To delay the application of the individual health insurance mandate, to delay the application of the employer health insurance mandate, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

5 **SEC. 101. SHORT TITLE.**

6 This title may be cited as the “Fairness for American  
 7 Families Act”.

8 **SEC. 102. DELAY IN APPLICATION OF INDIVIDUAL HEALTH**  
 9 **INSURANCE MANDATE.**

10 (a) IN GENERAL.—Section 5000A(a) of the Internal  
 11 Revenue Code of 1986 is amended by striking “2013” and  
 12 inserting “2014”.

13 (b) CONFORMING AMENDMENTS.—

14 (1) Section 5000A(c)(2)(B) of the Internal Rev-  
 15 enue Code of 1986 is amended—

16 (A) by striking “2014” in clause (i) and  
 17 inserting “2015”, and

18 (B) by striking “2015” in clauses (ii) and  
 19 (iii) and inserting “2016”.

20 (2) Section 5000A(c)(3)(B) of such Code is  
 21 amended—

1 (A) by striking “2014” and inserting  
2 “2015”, and

3 (B) by striking “2015” (prior to amend-  
4 ment by subparagraph (A)) and inserting  
5 “2016”.

6 (3) Section 5000A(e)(3)(D) of such Code is  
7 amended—

8 (A) by striking “2016” and inserting  
9 “2017”, and

10 (B) by striking “2015” and inserting  
11 “2016”.

12 (4) Section 5000A(e)(1)(D) of such Code is  
13 amended—

14 (A) by striking “2014” and inserting  
15 “2015”, and

16 (B) by striking “2013” and inserting  
17 “2014”.

18 (c) EFFECTIVE DATE.—The amendments made by  
19 this section shall take effect as if included in section 1501  
20 of the Patient Protection and Affordable Care Act.

## 21 **TITLE II—AUTHORITY FOR** 22 **MANDATE DELAY ACT**

### 23 **SEC. 201. SHORT TITLE.**

24 This title may be cited as the “Authority for Mandate  
25 Delay Act”.

1 **SEC. 202. DELAY IN APPLICATION OF EMPLOYER HEALTH**  
2 **INSURANCE MANDATE.**

3 (a) IN GENERAL.—Section 1513(d) of the Patient  
4 Protection and Affordable Care Act is amended by strik-  
5 ing “December 31, 2013” and inserting “December 31,  
6 2014”.

7 (b) REPORTING REQUIREMENTS.—

8 (1) REPORTING BY EMPLOYERS.—Section  
9 1514(d) of the Patient Protection and Affordable  
10 Care Act is amended by striking “December 31,  
11 2013” and inserting “December 31, 2014”.

12 (2) REPORTING BY INSURANCE PROVIDERS.—  
13 Section 1502(e) of the Patient Protection and Af-  
14 fordable Care Act is amended by striking “2013”  
15 and inserting “2014”.

16 (c) EFFECTIVE DATE.—The amendments made by  
17 this section shall take effect as if included in the provision  
18 of the Patient Protection and Affordable Care Act to  
19 which they relate.
