# A BILL

To preserve knowledge and promote education about jazz in the United States and abroad.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "National Jazz Preser-
- 5 vation and Education Act of 2011".

#### SEC. 2. NATIONAL JAZZ PRESERVATION PROGRAM.

- 2 (a) Establishment.—There is established a Na-
- 3 tional Jazz Preservation Program, to be carried out by
- 4 the Secretary of the Smithsonian Institution through the
- 5 Director of the National Museum of American History
- 6 and in collaboration with other Smithsonian museums, to
- 7 preserve knowledge and promote education about jazz.
- 8 (b) Program Components.—Under the National
- 9 Jazz Preservation Program, the Secretary of the Smithso-
- 10 nian Institution shall—
- 11 (1) record audio and video interviews with lead-
- ing jazz artists;
- 13 (2) acquire and preserve jazz artifacts, and in-
- terpret the artifacts through activities such as exhi-
- bitions and performances by the Smithsonian Jazz
- 16 Masterworks Orchestra;
- 17 (3) continue to recognize Jazz Appreciation
- Month; and
- 19 (4) establish, with governmental agencies, uni-
- versities, museums, and community-based organiza-
- 21 tions with jazz archival collections, collaborative
- agreements for the sharing of jazz artifacts.
- 23 (c) Authorization of Appropriations.—There is
- 24 authorized to be appropriated to carry out this section
- 25 \$2,000,000 for each of fiscal years 2012 through 2014,
- 26 to remain available until expended.

1	SEC. 3. JAZZ EDUCATION IN ELEMENTARY AND SEC-
2	ONDARY SCHOOLS.
3	Section 5411(b) of the Elementary and Secondary
4	Education Act of 1965 (20 U.S.C. 7243(b)) is amended—
5	(1) by redesignating paragraph (9) as para-
6	graph (10); and
7	(2) by inserting after paragraph (8) the fol-
8	lowing new paragraph:
9	"(9) Programs to promote jazz education,
0	which may include—
1	"(A) a Jazz Artists in the Schools program
2	to provide support for State arts agencies to
3	bring jazz artists to elementary and secondary
4	schools in collaboration with local educational
5	agencies;
6	"(B) a program for—
7	"(i) the development by jazz artists
8	and educators of lesson plans and other
9	educational materials about jazz;
20	"(ii) the distribution of such edu-
21	cational materials by organizations that
22	may include the National Endowment for
23	the Arts, educational institutions, or non-
24	profit organizations; and
25	"(iii) teacher training on jazz edu-
26	cation by jazz artists and educators: and

1 "(C) an Ambassadors of Jazz program to 2 send jazz musicians, and jazz orchestras from 3 secondary schools, abroad to perform for di-4 verse audiences on missions of goodwill, edu-5 cation, and cultural exchange, in collaboration 6 with the Secretary of State.".
