A BILL

To redesignate the Martin Luther King, Junior, National Historic Site in the State of Georgia, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Martin Luther King,
5 Jr. National Historical Park Act of 2015”.

1 **SEC. 2. MARTIN LUTHER KING, JR. NATIONAL HISTORICAL**
2 **PARK.**

3 The Act entitled “An Act to establish the Martin Lu-
4 ther King, Junior, National Historic Site in the State of
5 Georgia, and for other purposes” (Public Law 96–428)
6 is amended—

7 (1) in subsection (a) of the first section, by
8 striking “the map entitled ‘Martin Luther King,
9 Junior, National Historic Site’, numbered 489/
10 80,013B, and dated September 1992” and inserting
11 “the map entitled ‘Martin Luther King, Jr. National
12 Historical Park Proposed Boundary Revision’, num-
13 bered 489/128,786 and dated June 2015”;

14 (2) by striking “Martin Luther King, Junior,
15 National Historic Site” each place it appears and in-
16 sserting “Martin Luther King, Jr. National Histor-
17 ical Park”;

18 (3) by striking “national historic site” each
19 place it appears and inserting “national historical
20 park”; and

21 (4) by striking “historic site” each place it ap-
22 pears and inserting “historical park”.

23 **SEC. 3. REFERENCES.**

24 Any reference in a law (other than this Act), map,
25 regulation, document, paper, or other record of the United
26 States to “Martin Luther King, Junior, National Historic

- 1 Site” shall be deemed to be a reference to “Martin Luther
- 2 King, Jr. National Historical Park”.
