## A BILL

To authorize a Wall of Remembrance as part of the Korean War Veterans Memorial and to allow certain private contributions to fund that Wall of Remembrance.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. WALL OF REMEMBRANCE.**

4 Section 1 of the Act titled “An Act to authorize the  
5 erection of a memorial on Federal Land in the District  
6 of Columbia and its environs to honor members of the  
7 Armed Forces of the United States who served in the Ko-

1 rean War”, approved October 25, 1986 (Public Law 99–  
2 572), is amended by adding at the end the following:

3 “Such memorial shall include a Wall of Remembrance,  
4 which shall be constructed without the use of Federal  
5 funds. The American Battle Monuments Commission shall  
6 request and consider design recommendations from the  
7 Korean War Veterans Memorial Foundation, Inc. for the  
8 establishment of the Wall of Remembrance. The Wall of  
9 Remembrance shall include—

10           “(1) a list by name of members of the Armed  
11           Forces of the United States who were killed in ac-  
12           tion in the Korean War;

13           “(2) the number of members of the Armed  
14           Forces of the United States who, in regards to the  
15           Korean War—

16                   “(A) were wounded in action;

17                   “(B) are listed as missing in action; or

18                   “(C) were prisoners of war; and

19           “(3) the number of members of the Korean  
20           Augmentation to the United States Army, the Re-  
21           public of Korea Armed Forces, and the other na-  
22           tions of the United Nations Command who, in re-  
23           gards to the Korean War—

24                   “(A) were killed in action;

25                   “(B) were wounded in action;

- 1 “(C) are listed as missing in action; or
- 2 “(D) were prisoners of war.”.
