Mr. WALKER introduced the following bill; which was referred to the Committee on the Budget, and in addition to the Committee on Rules, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned

A BILL

To require Congress to budget in advance for disasters and
for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Budgeting for Disas-
5 ters Act”.

6 **SEC. 2. TERMINATION OF EXEMPTIONS FROM THE ANNUAL**
7 **BUDGET CAPS.**

8 Subparagraphs (D) and (F) of section 251(b)(2) of
9 the Balanced Budget and Emergency Deficit Control Act

1 of 1985 (2 U.S.C. 901(b)(2)) shall not apply with respect
2 to fiscal year 2020, or any fiscal year thereafter.

3 **SEC. 3. EMERGENCY SPENDING POINT OF ORDER.**

4 (a) IN GENERAL.—Section 314(e)(2) of the Congres-
5 sional Budget Act of 1974 (2 U.S.C. 645(e)(2)) is amend-
6 ed by striking “three-fifths” each place it appears and in-
7 serting “two-thirds”.

8 (b) EFFECTIVE DATE.—The amendments made by
9 subsection (a) shall—

10 (1) take effect on the date of enactment of this
11 Act; and

12 (2) apply with respect to fiscal year 2020, and
13 each fiscal year thereafter.

14 **SEC. 4. GAO REVIEW OF EMERGENCY SPENDING.**

15 (a) IN GENERAL.—Not later than 1 year after the
16 date of enactment of this Act, the Comptroller General
17 of the United States shall submit to Congress a report
18 that—

19 (1) reviews amounts appropriated for each of
20 fiscal years 2009 through 2018 that were—

21 (A) designated as being for an emergency
22 requirement;

23 (B) designated as being for disaster relief;

24 or

1 (C) made available to provide assistance
2 under the Robert T. Stafford Disaster Relief
3 and Emergency Assistance Act (42 U.S.C. 5121
4 et seq.);

5 (2) identifies and reviews amounts appropriated
6 for any of fiscal years 2009 through 2018 that were
7 designated as being for an emergency requirement
8 and designated as being for disaster relief; and

9 (3) provides recommendations to—

10 (A) clarify the definition of emergency re-
11 quirements for purposes of appropriated
12 amounts being designated as being for an emer-
13 gency requirement;

14 (B) implement an appropriate time limit
15 for recipients to spend appropriated amounts
16 that are designated as being for an emergency
17 requirement;

18 (C) improve cost-sharing relating to major
19 disasters and emergencies among Federal,
20 State, and local governments; and

21 (D) improve forecasting and budgeting for
22 appropriations for emergency requirements and
23 disaster relief.

24 (b) DEFINITIONS.—In this section—

1 (1) the term “emergency” means an emergency
2 declared by the President under section 501 of the
3 Robert T. Stafford Disaster Relief and Emergency
4 Assistance Act (42 U.S.C. 5191);

5 (2) the term “designated as being for an emer-
6 gency requirement”, with respect to amounts appro-
7 priated, means that the amounts are designated as
8 an emergency requirement pursuant to—

9 (A) section 251(b)(2)(A)(i) of the Bal-
10 anced Budget and Emergency Deficit Control
11 Act of 1985 (2 U.S.C. 901(b)(2)(A)(i)); or

12 (B) a provision of a concurrent resolution
13 on the budget;

14 (3) the term “designated as being for disaster
15 relief”, with respect to amounts appropriated, means
16 that the amounts are designated as being for dis-
17 aster relief pursuant to section 251(b)(2)(D) of the
18 Balanced Budget and Emergency Deficit Control
19 Act of 1985 (2 U.S.C. 901(b)(2)(D)); and

20 (4) the term “major disaster” means a major
21 disaster declared by the President under section 401
22 of the Robert T. Stafford Disaster Relief and Emer-
23 gency Assistance Act (42 U.S.C. 5170).
