# H. R. 3223

## AN ACT

To amend the Homeland Security Act of 2002 to establish in the Cybersecurity and Infrastructure Security Agency the National Cyber Exercise Program, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “CISA Cyber Exercise  
3 Act”.

4 **SEC. 2. NATIONAL CYBER EXERCISE PROGRAM.**

5 (a) IN GENERAL.—Subtitle A of title XXII of the  
6 Homeland Security Act of 2002 (6 U.S.C. 651 et seq.)  
7 is amended by adding at the end the following new section:

8 **“SEC. 2220A. NATIONAL CYBER EXERCISE PROGRAM.**

9 “(a) ESTABLISHMENT OF PROGRAM.—

10 “(1) IN GENERAL.—There is established in the  
11 Agency the National Cyber Exercise Program (re-  
12 ferred to in this section as the ‘Exercise Program’)  
13 to evaluate the National Cyber Incident Response  
14 Plan, and other related plans and strategies.

15 “(2) REQUIREMENTS.—

16 “(A) IN GENERAL.—The Exercise Program  
17 shall be—

18 “(i) based on current risk assess-  
19 ments, including credible threats,  
20 vulnerabilities, and consequences;

21 “(ii) designed, to the extent prac-  
22 ticable, to simulate the partial or complete  
23 incapacitation of a government or critical  
24 infrastructure network resulting from a  
25 cyber incident;

1 “(iii) designed to provide for the sys-  
2 tematic evaluation of cyber readiness and  
3 enhance operational understanding of the  
4 cyber incident response system and rel-  
5 evant information sharing agreements; and

6 “(iv) designed to promptly develop  
7 after-action reports and plans that can  
8 quickly incorporate lessons learned into fu-  
9 ture operations.

10 “(B) MODEL EXERCISE SELECTION.—The  
11 Exercise Program shall—

12 “(i) include a selection of model exer-  
13 cises that government and private entities  
14 can readily adapt for use; and

15 “(ii) aid such governments and pri-  
16 vate entities with the design, implementa-  
17 tion, and evaluation of exercises that—

18 “(I) conform to the requirements  
19 described in subparagraph (A);

20 “(II) are consistent with any ap-  
21 plicable national, State, local, or Trib-  
22 al strategy or plan; and

23 “(III) provide for systematic  
24 evaluation of readiness.

1           “(3) CONSULTATION.—In carrying out the Ex-  
2           ercise Program, the Director may consult with ap-  
3           propriate representatives from Sector Risk Manage-  
4           ment Agencies, cybersecurity research stakeholders,  
5           and Sector Coordinating Councils.

6           “(b) DEFINITIONS.—In this section:

7           “(1) STATE.—The term ‘State’ means any  
8           State of the United States, the District of Columbia,  
9           the Commonwealth of Puerto Rico, the Northern  
10          Mariana Islands, the United States Virgin Islands,  
11          Guam, American Samoa, and any other territory or  
12          possession of the United States.

13          “(2) PRIVATE ENTITY.—The term ‘private enti-  
14          ty’ has the meaning given such term in section 102  
15          of the Cybersecurity Information Sharing Act of  
16          2015 (6 U.S.C. 1501).”.

17          (b) TECHNICAL AMENDMENTS.—

18                 (1) HOMELAND SECURITY ACT OF 2002.—Sub-  
19                 title A of title XXII of the Homeland Security Act  
20                 of 2002 (6 U.S.C. 651 et seq.) is amended—

21                         (A) in the first section 2215 (6 U.S.C.  
22                         665; relating to the duties and authorities relat-  
23                         ing to .gov internet domain), by amending the  
24                         section enumerator and heading to read as fol-  
25                         lows:

1 **“SEC. 2215. DUTIES AND AUTHORITIES RELATING TO .GOV**  
2 **INTERNET DOMAIN.”;**

3 (B) in the second section 2215 (6 U.S.C.  
4 665b; relating to the joint cyber planning of-  
5 fice), by amending the section enumerator and  
6 heading to read as follows:

7 **“SEC. 2216. JOINT CYBER PLANNING OFFICE.”;**

8 (C) in the third section 2215 (6 U.S.C.  
9 665c; relating to the Cybersecurity State Coor-  
10 dinator), by amending the section enumerator  
11 and heading to read as follows:

12 **“SEC. 2217. CYBERSECURITY STATE COORDINATOR.”;**

13 (D) in the fourth section 2215 (6 U.S.C.  
14 665d; relating to Sector Risk Management  
15 Agencies), by amending the section enumerator  
16 and heading to read as follows:

17 **“SEC. 2218. SECTOR RISK MANAGEMENT AGENCIES.”;**

18 (E) in section 2216 (6 U.S.C. 665e; relat-  
19 ing to the Cybersecurity Advisory Committee),  
20 by amending the section enumerator and head-  
21 ing to read as follows:

22 **“SEC. 2219. CYBERSECURITY ADVISORY COMMITTEE.”;**

23 and

24 (F) in section 2217 (6 U.S.C. 665f; relat-  
25 ing to Cybersecurity Education and Training

1 Programs), by amending the section enu-  
2 merator and heading to read as follows:

3 **“SEC. 2220. CYBERSECURITY EDUCATION AND TRAINING**  
4 **PROGRAMS.”.**

5 (2) CONSOLIDATED APPROPRIATIONS ACT,  
6 2021.—Paragraph (1) of section 904(b) of division U  
7 of the Consolidated Appropriations Act, 2021 (Pub-  
8 lic Law 116–260) is amended, in the matter pre-  
9 ceding subparagraph (A), by inserting “of 2002”  
10 after “Homeland Security Act”.

11 (c) CLERICAL AMENDMENT.—The table of contents  
12 in section 1(b) of the Homeland Security Act of 2002 is  
13 amended by striking the items relating to sections 2214  
14 through 2217 and inserting the following new items:

“Sec. 2214. National Asset Database.

“Sec. 2215. Duties and authorities relating to .gov internet domain.

“Sec. 2216. Joint cyber planning office.

“Sec. 2217. Cybersecurity State Coordinator.

“Sec. 2218. Sector Risk Management Agencies.

“Sec. 2219. Cybersecurity Advisory Committee.

“Sec. 2220. Cybersecurity Education and Training Programs.

“Sec. 2220A. National Cyber Exercise Program.”.

## **AN ACT**
