## A BILL

To amend title 10, United States Code, to authorize representatives of veterans service organizations to promote certain benefits available to veterans in the course of preseparation counseling under the Transition Assistance program of the Department of Defense, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “TAP Promotion Act”.

1 **SEC. 2. PRESENTATION BY A VETERANS SERVICE ORGANI-**  
2 **ZATION IN TAP PRESEPARATION COUN-**  
3 **SELING.**

4 (a) IN GENERAL.—Section 1142(b) of title 10,  
5 United States Code, is amended by adding at the end the  
6 following new paragraph:

7 “(20) A presentation that promotes the benefits  
8 available to veterans under laws administered by the  
9 Secretary of Veterans Affairs. Such presentation—

10 “(A) shall be standardized;

11 “(B) shall be previously reviewed and ap-  
12 proved by the Secretary of Veterans Affairs;

13 “(C) shall be submitted by the Secretary of  
14 Veterans Affairs to the Committees on Vet-  
15 erans’ Affairs of the Senate and House of Rep-  
16 resentatives for review at least 90 days before  
17 implementation;

18 “(D) shall be presented by—

19 “(i) a national representative of a vet-  
20 erans service organization recognized  
21 under section 5902 of title 38; or

22 “(ii) if a national representative is un-  
23 available, a State or local representative of  
24 such an organization authorized by the  
25 Secretary concerned to so present;

1           “(E) shall include information on how a  
2           veterans service organization may assist the  
3           member in filing a claim described in paragraph  
4           (19);

5           “(F) may not encourage the member to  
6           join a particular veterans service organization;  
7           and

8           “(G) may not exceed one hour in length.”.

9           (b) ANNUAL REPORT.—Not less than once each year  
10          after the date of the enactment of this Act, the Secretary  
11          of Veterans Affairs shall submit to the Committees on  
12          Veterans’ Affairs of the Senate and House of Representa-  
13          tives a report—

14               (1) that identifies each veterans service organi-  
15               zation that presented under paragraph (20) of sec-  
16               tion 1142(b) of title 10, United States Code, as  
17               added by subsection (a);

18               (2) that contains the number of members of the  
19               Armed Forces who attended such presentations; and

20               (3) that includes any recommendations of the  
21               Secretary regarding changes to such presentation or  
22               to such paragraph.
