## A BILL

To amend the Marine Mammal Protection Act of 1972 to prohibit the taking, importation, and exportation of Orcas and Orca products for public display, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Orca Responsibility  
5 and Care Advancement Act of 2015”.

1 **SEC. 2. PROHIBITION ON TAKING, IMPORTATION, AND EX-**  
2 **PORTATION OF ORCAS AND ORCA PRODUCTS**  
3 **FOR PUBLIC DISPLAY.**

4 (a) PROHIBITION ON PERMITS FOR TAKING OR IM-  
5 PORTATION.—Section 104(a) of the Marine Mammal Pro-  
6 tection Act of 1972 (16 U.S.C. 1374(a)) is amended by  
7 inserting “(1)” after “(a)”, and by adding at the end the  
8 following:

9 “(2) Notwithstanding any other provision of law, no  
10 permit may be issued under this Act that authorizes the  
11 taking or importation of any marine mammal of the spe-  
12 cies *Orcinus orca*, or any marine mammal product that  
13 consists, or is composed in whole or in part, of such spe-  
14 cies, for the purpose of public display.”.

15 (b) PROHIBITION ON EXPORTATION FOR PUBLIC  
16 DISPLAY.—Section 102(a) of the Marine Mammal Protec-  
17 tion Act of 1972 (16 U.S.C. 1372(a)) is amended by strik-  
18 ing “and” after the semicolon at the end of paragraph  
19 (4), by striking the period at the end of paragraph (5)  
20 and inserting “; and”, and by adding at the end the fol-  
21 lowing:

22 “(6) notwithstanding any other provision of  
23 law, to export any marine mammal of the species  
24 *Orcinus orca*, or any marine mammal product that  
25 consists, or is composed in whole or in part, of such  
26 species, for the purpose of public display.”.

1 **SEC. 3. PROHIBITION ON BREEDING OF ORCAS.**

2       The Animal Welfare Act is amended by inserting  
3 after section 26 (7 U.S.C. 2156) the following new section:

4 **“SEC. 26A. BREEDING OF ORCAS.**

5       “*It shall be unlawful for any person to artificially in-*  
6 *seminate or breed a marine mammal of the species*  
7 *Orcinus orca for exhibition purposes.*”.
