A BILL

To designate the area between the intersections of International Drive, Northwest and Van Ness Street, Northwest and International Drive, Northwest and International Place, Northwest in Washington, District of Columbia, as “Tiananmen Square Memorial Boulevard”, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. DESIGNATION OF TIANANMEN SQUARE MEMO-**
2 **RIAL BOULEVARD.**

3 (a) DESIGNATION OF PLAZA.—

4 (1) IN GENERAL.—The area between the inter-
5 sections of International Drive, Northwest and Van
6 Ness Street, Northwest and International Drive,
7 Northwest and International Place, Northwest in
8 Washington, District of Columbia, shall be known
9 and designated as “Tiananmen Square Memorial
10 Boulevard”.

11 (2) REFERENCES.—Any reference in a law,
12 map, regulation, document, paper, or other record of
13 the area referred to in paragraph (1) shall be
14 deemed to be a reference to Tiananmen Square Me-
15 morial Boulevard.

16 (b) DESIGNATION OF ADDRESS.—

17 (1) DESIGNATION.—The address of 3505 Inter-
18 national Place, Northwest, Washington, District of
19 Columbia, shall be redesignated as 1 Tiananmen
20 Square Memorial Boulevard.

21 (2) REFERENCES.—Any reference in a law,
22 map, regulation, document, paper, or other record of
23 the United States to the address referred to in para-
24 graph (1) shall be deemed to be a reference to 1
25 Tiananmen Square Memorial Boulevard.

1 (c) SIGNS.—The Administrator of General Services
2 shall construct street signs that shall—

3 (1) contain the phrase “Tiananmen Square Me-
4 morial Boulevard”;

5 (2) be similar in design to the signs used by
6 Washington, District of Columbia, to designate the
7 location of Metro stations; and

8 (3) be placed on—

9 (A) the parcel of Federal property that is
10 closest to 1 Tiananmen Square Memorial Bou-
11 levard (as redesignated by subsection (b)); and

12 (B) the street corners of International
13 Drive, Northwest and Van Ness Street, North-
14 west and International Drive, Northwest and
15 International Place, Northwest, Washington,
16 District of Columbia.
