A BILL

To provide additional funding for scholarships for students
at 1890 institutions.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. ADDITIONAL FUNDING FOR SCHOLARSHIPS**
4 **FOR STUDENTS AT 1890 INSTITUTIONS.**

5 (a) *RESCISSION.*—*Of the unobligated balances from*
6 *amounts made available by section 1006 of the American*
7 *Rescue Plan Act (Public Law 117–2), the remaining unob-*
8 *ligated balance, or \$100,000,000, whichever is less, is hereby*
9 *rescinded.*

10 (b) *FUNDING.*—*In addition to amounts otherwise pro-*
11 *vided for carrying out section 1446 of the National Agricul-*
12 *tural Research, Extension, and Teaching Policy Act of 1977*
13 *(7 U.S.C. 3222a), there is appropriated to the Secretary*
14 *of Agriculture, out of amounts in the Treasury not other-*
15 *wise appropriated, an amount of additional new budget au-*
16 *thority equivalent to the amount rescinded under subsection*
17 *(a), to remain available until expended, to carry out such*
18 *section 1446.*

19 (c) *ADMINISTRATIVE FUNDS.*—*Of the funds made*
20 *available under section 1446(b)(4) of the National Agricul-*
21 *tural Research, Extension, and Teaching Policy Act of 1977*
22 *(7 U.S.C. 3222a(b)(4)) for a fiscal year, not more than 4*
23 *percent may be used for expenses related to administering*
24 *the program under such section 1446.*

1 (d) *EXTENSION.*—Section 1446(b) of the National Ag-
2 ricultural Research, Extension, and Teaching Policy Act of
3 1977 (7 U.S.C. 3222a(b)) is amended—

4 (1) in paragraph (2), by striking “each of fiscal
5 years 2020 through 2023” and inserting “fiscal year
6 2020 and each fiscal year thereafter”; and

7 (2) by adding at the end the following:

8 “(4) *FISCAL YEAR 2024 AND EACH FISCAL YEAR*
9 *THEREAFTER UNTIL OBLIGATED.*—Of the amounts
10 made available under section 1(b) of the Act entitled
11 ‘An Act to provide additional funding for scholar-
12 ships for students at 1890 institutions’, the Secretary
13 shall make available to carry out this section not less
14 than \$10,000,000 for fiscal year 2024 and each fiscal
15 year thereafter, until all funding made available
16 under such section 1(b) has been obligated.”.
