1 SECTION 1. SHORT TITLE.

2	This Act may be cited as the "Inland Empire Per-					
3	chlorate Ground Water Plume Assessment Act of 2010"					
4	SEC. 2. RIALTO-COLTON BASIN, CALIFORNIA, WATER RE					
5	SOURCES STUDY.					
6	(a) In General.—Not later than 2 years after fund					
7	are made available to carry out this Act, the Secretary					
8	of the Interior, acting through the Director of the United					
9	States Geological Survey, shall complete a study of water					
10	resources in the Rialto-Colton Basin in the State of Cali-					
11	fornia (in this section referred to as the "Basin"), includ-					
12	ing—					
13	(1) a survey of ground water resources in the					
14	Basin, including an analysis of—					
15	(A) the delineation, either horizontally or					
16	vertically, of the aquifers in the Basin, includ-					
17	ing the quantity of water in the aquifers;					
18	(B) the availability of ground water re-					
19	sources for human use;					
20	(C) the salinity of ground water resources;					
21	(D) the identification of a recent surge in					
22	perchlorate concentrations in ground water,					
23	whether significant sources are being flushed					
24	through the vadose zone, or if perchlorate is					
25	being remobilized;					

1	(E) the identification of impacts and					
2	extents of all source areas that contribute to					
3	the regional plume to be fully characterized;					
4	(F) the potential of the ground water re-					
5	sources to recharge;					
6	(G) the interaction between ground water					
7	and surface water;					
8	(H) the susceptibility of the aquifers to					
9	contamination, including identifying the exten					
10	of commingling of plume emanating within sur					
11	rounding areas in San Bernardino County					
12	California; and					
13	(I) any other relevant criteria; and					
14	(2) a characterization of surface and bedrock					
15	geology of the Basin, including the effect of the geol-					
16	ogy on ground water yield and quality.					
17	(b) COORDINATION.—The Secretary shall carry out					
18	the study in coordination with the State of California and					
19	any other entities that the Secretary determines to be ap					
20	propriate, including other Federal agencies and institu-					
21	tions of higher education.					
22	(c) Report.—Upon completion of the study, the Sec-					
23	retary shall submit to the Committee on Energy and Nat-					
24	ural Resources of the Senate and the Committee on Nat-					

- 1 ural Resources of the House of Representatives a report
- 2 that describes the results of the study.
