A BILL

To amend the Endangered Species Act of 1973 to improve the disclosure of certain expenditures under that Act, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Endangered Species Re-*
5 *covery Transparency Act”.*

6 **SEC. 2. DISCLOSURE OF EXPENDITURES UNDER ENDAN-**
7 **GERED SPECIES ACT OF 1973.**

8 *(a) REQUIREMENT TO DISCLOSE.—Section 13 of the*
9 *Endangered Species Act of 1973 (87 Stat. 902; relating to*
10 *conforming amendments which have executed) is amended*
11 *to read as follows:*

12 **“SEC. 13. DISCLOSURE OF EXPENDITURES.**

13 *“(a) REQUIREMENT.—The Secretary of the Interior, in*
14 *consultation with the Secretary of Commerce, shall—*

15 *“(1) not later than 90 days after the end of each*
16 *fiscal year, submit to the Committee on Natural Re-*
17 *sources of the House of Representatives and the Com-*
18 *mittee on Energy and Natural Resources of the Sen-*
19 *ate an annual report detailing Federal Government*
20 *expenditures for covered suits during the preceding*
21 *fiscal year (including the information described in*
22 *subsection (b)); and*

23 *“(2) make publicly available through the Inter-*
24 *net a searchable database of the information described*
25 *in subsection (b).*

1 “(b) *INCLUDED INFORMATION.*—*The report shall in-*
2 *clude—*

3 “(1) *the case name and number of each covered*
4 *suit, and a hyperlink to the record or decision for*
5 *each covered suit (if available);*

6 “(2) *a description of the claims in each covered*
7 *suit;*

8 “(3) *the name of each covered agency whose ac-*
9 *tions gave rise to a claim in a covered suit;*

10 “(4) *funds expended by each covered agency*
11 *(disaggregated by agency account) to receive and re-*
12 *spond to notices referred to in section 11(g)(2) or to*
13 *prepare for litigation of, litigate, negotiate a settle-*
14 *ment agreement or consent decree in, or provide mate-*
15 *rial, technical, or other assistance in relation to, a*
16 *covered suit;*

17 “(5) *the number of full-time equivalent employ-*
18 *ees that participated in the activities described in*
19 *paragraph (4); and*

20 “(6) *attorneys fees and other expenses*
21 *(disaggregated by agency account) awarded in covered*
22 *suits, including any consent decrees or settlement*
23 *agreements (regardless of whether a decree or settle-*
24 *ment agreement is sealed or otherwise subject to non-*

1 *disclosure provisions), including the bases for such*
2 *awards.*

3 “(c) *REQUIREMENT TO PROVIDE INFORMATION.—The*
4 *head of each covered agency shall provide to the Secretary*
5 *in a timely manner all information requested by the Sec-*
6 *retary to comply with the requirements of this section.*

7 “(d) *LIMITATION ON DISCLOSURE.—Notwithstanding*
8 *any other provision of this section, this section shall not*
9 *affect any restriction in a consent decree or settlement*
10 *agreement on the disclosure of information that is not de-*
11 *scribed in subsection (b).*

12 “(e) *DEFINITIONS.—*

13 “(1) *COVERED AGENCY.—The term ‘covered*
14 *agency’ means any agency of the Department of the*
15 *Interior, the Forest Service, the National Marine*
16 *Fisheries Service, the Bonneville Power Administra-*
17 *tion, the Western Area Power Administration, the*
18 *Southwestern Power Administration, or the South-*
19 *eastern Power Administration.*

20 “(2) *COVERED SUIT.—The term ‘covered suit’*
21 *means any civil action containing a claim against*
22 *the Federal Government, in which the claim arises*
23 *under this Act and is based on the action of a covered*
24 *agency.’”.*

1 **(b) CLERICAL AMENDMENT.**—*The table of contents in*
2 *the first section of such Act is amended by striking the item*
3 *relating to such section and inserting the following:*

 “*Sec. 13. Disclosure of expenditures.*”.

4 **(c) PRIOR AMENDMENTS NOT AFFECTED.**—*This sec-*
5 *tion shall not be construed to affect the amendments made*
6 *by section 13 of such Act, as in effect before the enactment*
7 *of this Act.*
