1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Protect Medical Inno-
 5 vation Act of 2011”.

6 **SEC. 2. REPEAL OF MEDICAL DEVICE EXCISE TAX.**
