Mr. COOK introduced the following bill; which was referred to the Committee on Natural Resources

A BILL

To redesignate the Johnson Valley Off-Highway Vehicle Recreation Area in California as the “Johnson Valley National Off-Highway Vehicle Recreation Area”, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. REDESIGNATION.**

4 (a) REDESIGNATION.—The Johnson Valley Off-High-
5 way Vehicle Recreation Area in California is hereby redес-
6 ignated as the “Johnson Valley National Off-Highway Ve-
7 hicle Recreation Area”.

1 (b) CONFORMING AMENDMENTS.—Subtitle C of title
2 XXIX of the National Defense Authorization Act for Fis-
3 cal Year 2014 (Public Law 113–66) is amended—

4 (1) in section 2942(c)(3), by striking “Johnson
5 Valley Off-Highway Vehicle Recreation Area” and
6 inserting “Johnson Valley National Off-Highway Ve-
7 hicle Recreation Area”; and

8 (2) in section 2945—

9 (A) in the section heading, by inserting
10 “**NATIONAL**” after “**VALLEY**”;

11 (B) in subsection (a), by inserting “Na-
12 tional” after “Valley” in the matter preceding
13 paragraph (1); and

14 (C) in subsections (b), (c), and (d), by in-
15 serting “National” after “Valley” each place it
16 appears.

17 (c) RELATION TO AUTHORIZED NAVY USE.—The re-
18 designation of the Johnson Valley Off-Highway Vehicle
19 Recreation Area as the “Johnson Valley National Off-
20 Highway Vehicle Recreation Area” does not alter or inter-
21 fere with the rights and obligations of the Navy regarding
22 the use of portions of the Recreation Area as provided in
23 subtitle C of title XXIX of the National Defense Author-
24 ization Act for Fiscal Year 2014 (Public Law 113–66).

1 (d) REFERENCES.—Any reference in any law, regula-
2 tion, document, record, map, or other paper of the United
3 States to the Johnson Valley Off-Highway Vehicle Recre-
4 ation Area is deemed to be a reference to the “Johnson
5 Valley National Off-Highway Vehicle Recreation Area”.
