# **A BILL**

To authorize the Secretary of the Interior to enter into an agreement to lease space from a nonprofit group or other government entity for a park headquarters at San Antonio Missions National Historical Park, to expand the boundary of the Park, to conduct a study of potential land acquisitions, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “San Antonio Missions*  
5 *National Historical Park Boundary Expansion Act of*  
6 *2010”.*

7 **SEC. 2. PARK HEADQUARTERS LEASE AND BOUNDARY**  
8 **STUDY.**

9 *Section 201 of Public Law 95–629 (16 U.S.C. 410ee)*  
10 *is amended—*

11 *(1) by redesignating subsections (b), (c), (d), (e),*  
12 *and (f) as subsections (c), (e), (f), (g), and (h) respec-*  
13 *tively;*

14 *(2) by inserting after subsection (a) the following*  
15 *new subsection:*

16 *“(b)(1) The Secretary shall conduct a study of lands*  
17 *within Bexar and Wilson Counties, Texas, to identify lands*  
18 *that would be suitable for inclusion within the boundaries*  
19 *of the park. In conducting the study, the Secretary shall*  
20 *examine the natural, cultural, recreational, and scenic val-*  
21 *ues and characteristics of lands within Bexar and Wilson*  
22 *Counties.*

23 *“(2) Not later than 3 years after the date funds are*  
24 *made available for the study under paragraph (1), the Sec-*  
25 *retary shall submit to the Committee on Natural Resources*

1 *of the House of Representatives and the Committee on En-*  
2 *ergy and Natural Resources of the Senate a report on the*  
3 *findings, conclusions, and recommendations of the study.”;*  
4 *and*

5           (3) *by inserting after subsection (c) (as so reded-*  
6 *ignated) the following new subsection:*

7           “(d)(1) *The Secretary may enter into a cooperative*  
8 *agreement with the City of San Antonio or its designee,*  
9 *for operation of a facility outside the boundary of the park*  
10 *that would provide—*

11           “(A) *office space for a headquarters and oper-*  
12 *ational support for the park; and*

13           “(B) *a center for research and education.*

14           “(2) *The Secretary may plan, design, construct, and*  
15 *install in the facilities described in the cooperative agree-*  
16 *ment exhibits related to the resources at the park.*

17           “(3) *Notwithstanding the location of the facility de-*  
18 *scribed in the cooperative agreement, the Secretary may as-*  
19 *sign park staff from the park to provide interpretive serv-*  
20 *ices, including visitor information and education.”.*

21 **SEC. 3. BOUNDARY EXPANSION.**

22           *Section 201(a) of Public Law 95–629 (16 U.S.C.*  
23 *410ee(a)) is amended as follows:*

24           (1) *By striking “In order” and inserting the fol-*  
25 *lowing: “(1) In order”.*

1           (2) *By striking “The park shall also” and insert-*  
2           *ing the following:*

3           “(2) *The park shall also*”.

4           (3) *By striking “After advising the” and insert-*  
5           *ing the following:*

6           “(4) *After advising the*”.

7           (4) *By inserting after paragraph (2) (as so des-*  
8           *ignated by paragraph (2) above) the following:*

9           “(3) *The boundary of the park is further modified to*  
10          *include approximately 151 acres, as depicted on the map*  
11          *titled ‘San Antonio Missions National Historical Park Pro-*  
12          *posed Boundary Addition 2009’, numbered 472/68,027, and*  
13          *dated November 2009. The map shall be on file and avail-*  
14          *able for inspection in the appropriate offices of the National*  
15          *Park Service, U.S. Department of the Interior. The Sec-*  
16          *retary of the Interior may not use condemnation authority*  
17          *to acquire any lands or interests in lands under this Act.*”.

Amend the title so as to read: “A bill to authorize the Secretary of the Interior to enter into a cooperative agreement for a park headquarters at San Antonio Missions National Historical Park, to expand the boundary of the Park, to conduct a study of potential land acquisitions, and for other purposes.”.
