SECTION 1. SHORT TITLE.

- This Act may be cited as the "San Antonio Missions"
- 3 National Historical Park Boundary Expansion Act of
- 4 2010".

5 SEC. 2. PARK BOUNDARY STUDY.

- 6 Section 201 of Public Law 95–629 (16 U.S.C. 410ee)
- 7 is amended—
- 8 (1) by redesignating subsections (b), (c), (d),
- 9 (e), and (f) as subsections (c), (e), (f), (g), and (h)
- 10 respectively;
- 11 (2) by inserting after subsection (a) the fol-
- lowing new subsection:
- 13 ``(b)(1) The Secretary shall conduct a study of lands
- 14 within Bexar and Wilson Counties, Texas, to identify
- 15 lands that would be suitable for inclusion within the
- 16 boundaries of the park. In conducting the study, the Sec-
- 17 retary shall examine the natural, cultural, recreational,
- 18 and scenic values and characteristics of lands within
- 19 Bexar and Wilson Counties.
- 20 "(2) Not later than 3 years after the date funds are
- 21 made available for the study under paragraph (1), the Sec-
- 22 retary shall submit to the Committee on Natural Re-
- 23 sources of the House of Representatives and the Com-
- 24 mittee on Energy and Natural Resources of the Senate
- 25 a report on the findings, conclusions, and recommenda-
- 26 tions of the study."; and

1 (3) by inserting after subsection (c) (as so re-2 designated) the following new subsection: 3 "(d) The Secretary may assign park employees to provide interpretive services, including visitor information 5 and education, at facilities outside the boundary of the 6 park.". SEC. 3. BOUNDARY EXPANSION. 8 Section 201(a) of Public Law 95–629 (16 U.S.C. 9 410ee(a)) is amended as follows: 10 (1) By striking "In order" and inserting the 11 following: "(1) In order". (2) By striking "The park shall also" and in-12 13 serting the following: 14 "(2) The park shall also". 15 (3) By striking "After advising the" and insert-16 ing the following: 17 "(4) After advising the". 18 (4) By inserting after paragraph (2) (as so des-19 ignated by paragraph (2) above) the following: 20 "(3) The boundary of the park is further modified 21 to include approximately 151 acres, as depicted on the map titled 'San Antonio Missions National Historical 23 Park Proposed Boundary Addition 2009', numbered 472/ 68,027, and dated November 2009. The map shall be on file and available for inspection in the appropriate offices

- 1 of the National Park Service, U.S. Department of the In-
- 2 terior. The Secretary of the Interior may not use con-
- 3 demnation authority to acquire any lands or interests in
- 4 lands under this Act.".
