# **A BILL**

To require a review of women and lung cancer, and for  
other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Women and Lung Can-*  
5 *cer Research and Preventive Services Act of 2024”.*

6 **SEC. 2. INTERAGENCY REVIEW TO EVALUATE AND IDEN-**  
7 **TIFY OPPORTUNITIES FOR THE ACCELERA-**  
8 **TION OF RESEARCH ON LUNG CANCER IN**  
9 **WOMEN AND UNDERSERVED POPULATIONS,**  
10 **GREATER ACCESS TO PREVENTIVE SERVICES,**  
11 **AND STRATEGIC PUBLIC AWARENESS AND**  
12 **EDUCATION CAMPAIGNS.**

13 *(a) IN GENERAL.—The Secretary of Health and*  
14 *Human Services, in consultation with the Secretary of De-*  
15 *fense and Secretary of Veterans Affairs, shall conduct an*  
16 *interagency review to evaluate the status of, and identify*  
17 *opportunities related to—*

18 *(1) research on lung cancer in women;*

19 *(2) research on lung cancer in underserved popu-*  
20 *lations that meet the eligibility criteria for lung can-*  
21 *cer screening as recommended by the United States*  
22 *Preventive Services Task Force;*

23 *(3) access to lung cancer preventive services; and*

24 *(4) strategic public awareness and education*  
25 *campaigns on lung cancer.*

1       (b) *CONTENT.*—*The review and recommendations*  
2 *under subsection (a) shall include—*

3           (1) *a review and comprehensive report on the*  
4 *outcomes of previous research, the status of existing*  
5 *research activities, and knowledge gaps related to*  
6 *lung cancer in women and underserved populations*  
7 *in all agencies of the Federal Government;*

8           (2) *opportunities for collaborative, interagency,*  
9 *multidisciplinary, and innovative research, that*  
10 *would—*

11           (A) *encourage innovative approaches to*  
12 *eliminate knowledge gaps in research on lung*  
13 *cancer in women;*

14           (B) *evaluate environmental and genomic*  
15 *factors that may be related to the etiology of lung*  
16 *cancer in women; and*

17           (C) *foster advances in imaging technology*  
18 *and techniques to improve risk assessment, diag-*  
19 *nosis, treatment, and the simultaneous utiliza-*  
20 *tion of other preventive services and activities;*

21           (3) *opportunities regarding the development of a*  
22 *national lung cancer screening strategy to expand ac-*  
23 *cess to such screenings, particularly among women*  
24 *and underserved populations; and*

1           (4) opportunities regarding the development of a  
2           national public education and awareness campaign  
3           on—

4                   (A) lung cancer in women and underserved  
5                   populations; and

6                   (B) the importance of early detection of  
7                   lung cancer.

8           (c) *REPORT.*—Not later than two years after the date  
9           of the enactment of this Act, the Secretary of Health and  
10          Human Services shall submit to Congress a report on the  
11          review conducted under subsection (a).
