## A BILL

To provide for the establishment of a pilot program to encourage the employment of veterans in manufacturing positions.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be referred to as the “Manufacturing  
5 Jobs for Veterans Act”.

1 **SEC. 2. VETERANS MANUFACTURING EMPLOYMENT PRO-**  
2 **GRAM.**

3 (a) ESTABLISHMENT OF PILOT PROGRAM.—To en-  
4 courage the employment of eligible veterans in manufac-  
5 turing, the Secretary of Labor, as part of the Veteran’s  
6 Workforce Investment Program, shall carry out a pilot  
7 program to be known as the “Veterans Manufacturing  
8 Employment Program”. Under the pilot program, the Sec-  
9 retary shall award competitive grants to three States for  
10 the establishment and administration of a State program  
11 to make grants to manufacturing employers and labor-  
12 management organizations that provide covered training,  
13 on-job training, apprenticeships, and certification classes  
14 to eligible veterans. Such a program shall be known as  
15 a “State Manufacturing Employment Program”.

16 (b) ELIGIBILITY FOR GRANTS.—To be eligible to re-  
17 ceive a grant under the pilot program, a State shall submit  
18 to the Secretary an application that includes each of the  
19 following:

20 (1) A proposal for the expenditure of grant  
21 funds to establish and administer a public-private  
22 partnership program designed to provide covered  
23 training, on-job training, apprenticeships, and cer-  
24 tification classes to a significant number of eligible  
25 veterans and ensure lasting and sustainable employ-  
26 ment in well-paying jobs in manufacturing.

1 (2) Evidence that the State has—

2 (A) a population of eligible veterans of an  
3 appropriate size to carry out the State program;

4 (B) a robust and diverse manufacturing in-  
5 dustry; and

6 (C) the ability to carry out the State pro-  
7 gram described in the proposal under para-  
8 graph (1).

9 (3) Such other information and assurances as  
10 the Secretary may require.

11 (c) USE OF FUNDS.—A State that is the recipient  
12 of a grant under this section shall use the grant for the  
13 following purposes:

14 (1) Making grants to manufacturing employers  
15 and labor-management organizations to reimburse  
16 such employers and organizations for the cost of  
17 providing covered training, on-job training, appren-  
18 ticeships, and certification classes to eligible vet-  
19 erans.

20 (2) Conducting outreach to inform manufac-  
21 turing employers, labor-management organizations,  
22 and veterans, including veterans in rural areas, of  
23 their eligibility or potential eligibility for participa-  
24 tion in the State program.

1 (d) CONDITIONS.—Under the pilot program, each  
2 grant to a State shall be subject to the following condi-  
3 tions:

4 (1) The State shall repay to the Secretary, on  
5 such date as shall be determined by the Secretary,  
6 any amount received under the pilot program that is  
7 not used for the purposes described in subsection  
8 (c).

9 (2) The State shall submit to the Secretary, at  
10 such times and containing such information as the  
11 Secretary shall require, reports on the use of grant  
12 funds.

13 (e) EMPLOYER REQUIREMENTS.—In order to receive  
14 a grant made by a State under the pilot program, a manu-  
15 facturing employer shall—

16 (1) submit to the administrator of the State  
17 Manufacturing Employment Program an application  
18 that includes—

19 (A) the rate of pay for each eligible vet-  
20 eran proposed to be trained using grant funds;

21 (B) the average rate of pay for an indi-  
22 vidual employed by the manufacturing employer  
23 in a similar position who is not an eligible vet-  
24 eran; and

1 (C) such other information and assurances  
2 as the administrator may require; and

3 (2) agree to submit to the administrator, for  
4 each quarter, a report containing such information  
5 as the Secretary may specify.

6 (f) LIMITATION.—None of the funds made available  
7 to a manufacturing employer through a grant under the  
8 pilot program may be used to provide training of any kind  
9 to a person who is not an eligible veteran.

10 (g) REPORT TO CONGRESS.—Together with the re-  
11 port required to be submitted annually under section  
12 4107(c) of title 38, United States Code, the Secretary  
13 shall submit to Congress a report on the pilot program  
14 for the year covered by such report. The report on the  
15 pilot program shall include a detailed description of activi-  
16 ties carried out under this section and an evaluation of  
17 the program.

18 (h) ADMINISTRATIVE AND REPORTING COSTS.—Of  
19 the amounts appropriated pursuant to the authorization  
20 of appropriations under subsection (j), 2 percent shall be  
21 made available to the Secretary for administrative costs  
22 associated with implementing and evaluating the pilot pro-  
23 gram under this section and for preparing and submitting  
24 the report required under subsection (f). The Secretary  
25 shall determine the appropriate maximum amount of each

1 grant awarded under this section that may be used by the  
2 recipient for administrative and reporting costs.

3 (i) DEFINITIONS.—For purposes of this section:

4 (1) The term “covered training, on-job training,  
5 apprenticeships, and certification classes” means  
6 training, on-job training, apprenticeships, and cer-  
7 tification classes that are—

8 (A) designed to provide the veteran with  
9 skills that are particular to manufacturing and  
10 not directly transferable to employment in an-  
11 other industry; and

12 (B) approved as provided in paragraph (1)  
13 or (2), as appropriate, of subsection (a) of sec-  
14 tion 3687 of title 38, United States Code.

15 (2) The term “eligible veteran” means a vet-  
16 eran, as that term is defined in section 101(3) of  
17 title 38, United States Code, who is employed by a  
18 manufacturing employer and enrolled or partici-  
19 pating in a covered training, on-job training, appren-  
20 ticeship, or certification class.

21 (3) The term “manufacturing employer” means  
22 a business concern—

23 (A) that employs individuals in a trade or  
24 business in manufacturing;

1                   (B) the production facilities of which are  
2                   located in the United States; and

3                   (C) the primary business of which is classi-  
4                   fied in sector 31, 32, or 33 of the North Amer-  
5                   ican Industrial Classification System.

6           (j) APPROPRIATIONS.—There is authorized to be ap-  
7           propriated to the Secretary \$10,000,000 for each of fiscal  
8           years 2015 through 2019, for the purpose of carrying out  
9           the pilot program.
