## A BILL

To authorize appropriations for fiscal year 2015 for intelligence and intelligence-related activities of the United States Government, the Community Management Account, and the Central Intelligence Agency Retirement and Disability System, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Intelligence Authoriza-  
5       tion Act for Fiscal Year 2015”.

1                   **TITLE I—INTELLIGENCE**  
2                   **ACTIVITIES**

3 **SEC. 101. AUTHORIZATION OF APPROPRIATIONS.**

4           Funds are hereby authorized to be appropriated for  
5 fiscal year 2015 for the conduct of the intelligence and  
6 intelligence-related activities of the following elements of  
7 the United States Government:

8                   (1) The Office of the Director of National Intel-  
9                   ligence.

10                   (2) The Central Intelligence Agency.

11                   (3) The Department of Defense.

12                   (4) The Defense Intelligence Agency.

13                   (5) The National Security Agency.

14                   (6) The Department of the Army, the Depart-  
15                   ment of the Navy, and the Department of the Air  
16                   Force.

17                   (7) The Coast Guard.

18                   (8) The Department of State.

19                   (9) The Department of the Treasury.

20                   (10) The Department of Energy.

21                   (11) The Department of Justice.

22                   (12) The Federal Bureau of Investigation.

23                   (13) The Drug Enforcement Administration.

24                   (14) The National Reconnaissance Office.

1           (15) The National Geospatial-Intelligence Agen-  
2           cy.

3           (16) The Department of Homeland Security.

4 **SEC. 102. CLASSIFIED SCHEDULE OF AUTHORIZATIONS.**

5           (a) SPECIFICATIONS OF AMOUNTS AND PERSONNEL  
6 LEVELS.—The amounts authorized to be appropriated  
7 under section 101 and, subject to section 103, the author-  
8 ized personnel ceilings as of September 30, 2015, for the  
9 conduct of the intelligence activities of the elements listed  
10 in paragraphs (1) through (16) of section 101, are those  
11 specified in the classified Schedule of Authorizations pre-  
12 pared to accompany the bill H.R. \_\_\_\_ of the One Hun-  
13 dred Thirteenth Congress.

14           (b) AVAILABILITY OF CLASSIFIED SCHEDULE OF AU-  
15 THORIZATIONS.—

16           (1) AVAILABILITY.—The classified Schedule of  
17 Authorizations referred to in subsection (a) shall be  
18 made available to the Committee on Appropriations  
19 of the Senate, the Committee on Appropriations of  
20 the House of Representatives, and to the President.

21           (2) DISTRIBUTION BY THE PRESIDENT.—Sub-  
22 ject to paragraph (3), the President shall provide for  
23 suitable distribution of the classified Schedule of Au-  
24 thorizations, or of appropriate portions of the Sched-  
25 ule, within the executive branch.

1           (3) LIMITS ON DISCLOSURE.—The President  
2 shall not publicly disclose the classified Schedule of  
3 Authorizations or any portion of such Schedule ex-  
4 cept—

5                   (A) as provided in section 601(a) of the  
6           Implementing Recommendations of the 9/11  
7           Commission Act of 2007 (50 U.S.C. 3306(a));

8                   (B) to the extent necessary to implement  
9           the budget; or

10                   (C) as otherwise required by law.

11 **SEC. 103. PERSONNEL CEILING ADJUSTMENTS.**

12           (a) AUTHORITY FOR INCREASES.—With the approval  
13 of the Director of the Office of Management and Budget,  
14 the Director of National Intelligence may authorize em-  
15 ployment of civilian personnel in excess of the number of  
16 positions authorized for fiscal year 2015 by the classified  
17 Schedule of Authorizations referred to in section 102(a)  
18 if the Director of National Intelligence determines that  
19 such action is necessary to the performance of important  
20 intelligence functions, except that the number of personnel  
21 employed in excess of the number authorized under such  
22 section may not, for any element of the intelligence com-  
23 munity, exceed 3 percent of the number of civilian per-  
24 sonnel authorized under such Schedule for such element.

1 (b) TREATMENT OF CERTAIN PERSONNEL.—The Di-  
2 rector of National Intelligence shall establish guidelines  
3 that govern, for each element of the intelligence commu-  
4 nity, the treatment under the personnel levels authorized  
5 under section 102(a), including any exemption from such  
6 personnel levels, of employment or assignment in—

7 (1) a student program, trainee program, or  
8 similar program;

9 (2) a reserve corps or as a reemployed annu-  
10 itant; or

11 (3) details, joint duty, or long-term, full-time  
12 training.

13 (c) NOTICE TO CONGRESSIONAL INTELLIGENCE  
14 COMMITTEES.—The Director of National Intelligence  
15 shall notify the congressional intelligence committees in  
16 writing at least 15 days prior to each exercise of an au-  
17 thority described in subsection (a).

18 **SEC. 104. INTELLIGENCE COMMUNITY MANAGEMENT AC-**  
19 **COUNT.**

20 (a) AUTHORIZATION OF APPROPRIATIONS.—There is  
21 authorized to be appropriated for the Intelligence Commu-  
22 nity Management Account of the Director of National In-  
23 telligence for fiscal year 2015 the sum of  
24 \$\_\_\_\_\_. Within such amount, funds  
25 identified in the classified Schedule of Authorizations re-

1 referred to in section 102(a) for advanced research and de-  
2 velopment shall remain available until September 30,  
3 2016.

4 (b) AUTHORIZED PERSONNEL LEVELS.—The ele-  
5 ments within the Intelligence Community Management  
6 Account of the Director of National Intelligence are au-  
7 thorized \_\_\_\_\_ positions as of September 30, 2015. Per-  
8 sonnel serving in such elements may be permanent em-  
9 ployees of the Office of the Director of National Intel-  
10 ligence or personnel detailed from other elements of the  
11 United States Government.

12 (c) CLASSIFIED AUTHORIZATIONS.—

13 (1) AUTHORIZATION OF APPROPRIATIONS.—In  
14 addition to amounts authorized to be appropriated  
15 for the Intelligence Community Management Ac-  
16 count by subsection (a), there are authorized to be  
17 appropriated for the Community Management Ac-  
18 count for fiscal year 2015 such additional amounts  
19 as are specified in the classified Schedule of Author-  
20 izations referred to in section 102(a). Such addi-  
21 tional amounts for advanced research and develop-  
22 ment shall remain available until September 30,  
23 2016.

24 (2) AUTHORIZATION OF PERSONNEL.—In addi-  
25 tion to the personnel authorized by subsection (b)

1 for elements of the Intelligence Community Manage-  
2 ment Account as of September 30, 2015, there are  
3 authorized such additional personnel for the Com-  
4 munity Management Account as of that date as are  
5 specified in the classified Schedule of Authorizations  
6 referred to in section 102(a).

7 **TITLE II—CENTRAL INTEL-**  
8 **LIGENCE AGENCY RETIRE-**  
9 **MENT AND DISABILITY SYS-**  
10 **TEM**

11 **SEC. 201. AUTHORIZATION OF APPROPRIATIONS.**

12 There is authorized to be appropriated for the Cen-  
13 tral Intelligence Agency Retirement and Disability Fund  
14 for fiscal year 2015 the sum of \$\_\_\_\_\_.

15 **TITLE III—GENERAL**  
16 **PROVISIONS**

17 **SEC. 301. INCREASE IN EMPLOYEE COMPENSATION AND**  
18 **BENEFITS AUTHORIZED BY LAW.**

19 Appropriations authorized by this Act for salary, pay,  
20 retirement, and other benefits for Federal employees may  
21 be increased by such additional or supplemental amounts  
22 as may be necessary for increases in such compensation  
23 or benefits authorized by law.

1 **SEC. 302. RESTRICTION ON CONDUCT OF INTELLIGENCE**  
2 **ACTIVITIES.**

3       The authorization of appropriations by this Act shall  
4 not be deemed to constitute authority for the conduct of  
5 any intelligence activity which is not otherwise authorized  
6 by the Constitution or the laws of the United States.
