## A BILL

To direct the Secretary of Labor to carry out a research program to evaluate the effectiveness of the Transition Assistance Program in addressing the needs of certain minority veterans.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Success in Transition  
5 for All Veterans Act”.

1 **SEC. 2. RESEARCH PROGRAM TO EVALUATE EFFECTIVE-**  
2 **NESS OF TRANSITION ASSISTANCE PROGRAM**  
3 **IN ADDRESSING NEEDS OF CERTAIN MINOR-**  
4 **ITY VETERANS.**

5 (a) RESEARCH PROGRAM.—Beginning not later than  
6 June 1, 2017, the Secretary of Labor, in collaboration  
7 with the Secretary of Veterans Affairs and the Secretary  
8 of Defense, shall carry out a research program to evaluate  
9 the Transition Assistance Program under section 1144 of  
10 title 10, United States Code. Such research program shall  
11 be designed to determine how effectively the Transition  
12 Assistance Program addresses the differentiated needs,  
13 challenges, and post-military service aspirations of women  
14 veterans, veterans with disabilities, Native American vet-  
15 erans, veterans who are residents of a territory of the  
16 United States, veterans who are part of the indigenous  
17 population of a territory of the United States, and other  
18 groups of minority veterans identified by the Secretaries.

19 (b) ISSUES ADDRESSED.—The Secretary of Labor  
20 shall ensure that the research program required under  
21 subsection (a) addresses each of the following issues:

22 (1) In the context of the transition experience,  
23 whether and how the barriers to employment facing  
24 women veterans, veterans with disabilities, Native  
25 American veterans, veterans who are residents of a  
26 territory of the United States, veterans who are part

1 of the indigenous population of a territory of the  
2 United States, and other identified groups of minor-  
3 ity veterans are substantively different from other  
4 populations of the veteran community.

5 (2) In the context of the transition experience,  
6 whether and how the post-military service employ-  
7 ment aspirations such groups of veterans covered by  
8 the research project are substantively different from  
9 such aspirations of other populations of the veteran  
10 community.

11 (3) To the extent that any barriers to employ-  
12 ment or aspirations are identified under paragraph  
13 (1) or (2) as being substantially different for any of  
14 the groups of veterans covered by the research  
15 project, whether the Transition Assistance Program  
16 is designed to appropriately address those dif-  
17 ferences.

18 (4) To the extent that the Transition Assist-  
19 ance Program is determined not to be designed to  
20 appropriately address a difference under paragraph  
21 (3), an identification of any change that could be  
22 made to the Program to more appropriately address  
23 such difference.

24 (c) REPORT REQUIRED.—Not later than one year  
25 after the date of the commencement of the research pro-

- 1 gram under this section, the Secretary of Labor shall sub-
- 2 mit to Congress a report on the research program.
