A BILL

To amend title 5, United States Code, to provide for recalculation of basic annuity benefits for certain air traffic controllers, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. COMPUTATION OF BASIC ANNUITY FOR CER-**
4 **TAIN AIR TRAFFIC CONTROLLERS.**

5 (a) IN GENERAL.—Section 8415(f) of title 5, United
6 States Code, is amended to read as follows:

7 “(f) The annuity of an air traffic controller or former
8 air traffic controller retiring under section 8412(a) is com-
9 puted under subsection (a), except that if the individual
10 has at least 5 years of service in any combination as—

11 “(1) an air traffic controller as defined by sec-
12 tion 2109(1)(A)(i);

13 “(2) a first level supervisor of an air traffic
14 controller as defined by section 2109(1)(A)(i); or

15 “(3) a second level supervisor of an air traffic
16 controller as defined by section 2109(1)(A)(i);

17 so much of the annuity as is computed with respect to
18 such type of service shall be computed by multiplying $1\frac{7}{10}$
19 percent of the individual’s average pay by the years of
20 such service.”.

21 (b) EFFECTIVE DATE.—The amendment made by
22 subsection (a) shall be deemed to be effective on December
23 12, 2003.

1 (c) PROCEDURES REQUIRED.—The Director of the
2 Office of Personnel Management shall establish such pro-
3 cedures as are necessary to provide for—

4 (1) notification to each annuitant affected by
5 the amendments made by this section;

6 (2) recalculation of the benefits of affected an-
7 nuitants;

8 (3) an adjustment to applicable monthly benefit
9 amounts pursuant to such recalculation, to begin as
10 soon as is practicable; and

11 (4) a lump sum payment to each affected annu-
12 itant equal to the additional total benefit amount
13 that such annuitant would have received had the
14 amendment made by subsection (a) been in effect on
15 December 12, 2003.
