## A BILL

To direct the Secretary of Education to develop resources to reduce e-cigarette use by students on campuses of institutions of higher education, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Vaping Prevention on  
5 College Campuses Act of 2020”.

1 **SEC. 2. RESOURCES FOR REDUCING E-CIGARETTE USE ON**  
2 **CAMPUSES OF INSTITUTIONS OF HIGHER**  
3 **EDUCATION.**

4 (a) **IN GENERAL.**—Not later than 1 year after the  
5 date of the enactment of this Act, the Secretary of Edu-  
6 cation (referred to in this section as the “Secretary”) shall  
7 develop resources to assist institutions of higher education  
8 to reduce the use of e-cigarettes by students on campuses  
9 and improve the short-term and long-term health out-  
10 comes of such students.

11 (b) **CONSULTATION.**—In developing resources under  
12 subsection (a), the Secretary shall consult with—

13 (1) the Secretary of Health and Human Serv-  
14 ices;

15 (2) institutions of higher education, including  
16 student representatives thereof; and

17 (3) public health organizations.

18 (c) **CONTENTS.**—Resources developed under sub-  
19 section (a) may include—

20 (1) action plans for ending e-cigarette use on  
21 campuses;

22 (2) visual aids informing students of the dan-  
23 gers of e-cigarette use;

24 (3) instructional materials designed to prevent  
25 student e-cigarette use; and

1           (4) a directory of healthcare providers that spe-  
2           cialize in nicotine addiction treatment.

3           (d) AVAILABILITY.—The Secretary shall make the re-  
4           sources developed under subsection (a) available on a pub-  
5           licly accessible website of the Department of Education.

6           (e) INSTITUTION OF HIGHER EDUCATION DE-  
7           FINED.—In this section, the term “institution of higher  
8           education” has the meaning given such term in section  
9           102 of the Higher Education Act of 1965 (20 U.S.C.  
10          1002).
