## A BILL

To amend the Federal charter of the United States Olympic Committee to require the United States Olympic Committee to ensure that goods donated or supplied to athletes are substantially made in the United States, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “American Clothing for  
5 American Olympians Act”.

1 **SEC. 2. REQUIREMENT FOR UNITED STATES OLYMPIC COM-**  
2 **MITTEE TO ENSURE CERTAIN GOODS ARE**  
3 **SUBSTANTIALLY MADE IN THE UNITED**  
4 **STATES.**

5 (a) **REQUIREMENT RELATING TO AMERICAN-MADE**  
6 **GOODS AND SERVICES.**—Section 220506(b) of title 36,  
7 United States Code, is amended by adding at the end the  
8 following: “In authorizing contributors and suppliers  
9 under this subsection, the corporation shall ensure that  
10 all goods to be donated or supplied to any amateur athlete,  
11 coach, trainer, manager, administrator, or official of the  
12 United States Olympic team, the Paralympic team, or the  
13 Pan-American team are substantially made in the United  
14 States, to the extent the goods are available in the United  
15 States. For purposes of the preceding sentence, the term  
16 ‘substantially made in the United States’ means that the  
17 cost of the foreign products used in the materials in the  
18 goods constitutes less than 50 percent of the cost of all  
19 the products used in such materials.”.

20 (b) **REPORT REQUIREMENT.**—Section 220511 of  
21 such title is amended—

22 (1) by striking “and” at the end of paragraph  
23 (3);

24 (2) by striking the period at the end of para-  
25 graph (4) and inserting the following: “; and”; and

1           (3) by adding at the end the following new  
2 paragraph:

3           “(5) data concerning the sources of the goods  
4 donated or supplied to any amateur athlete, coach,  
5 trainer, manager, administrator, or official of the  
6 United States Olympic team, the Paralympic team,  
7 or the Pan-American team, and a description of the  
8 steps taken to ensure the goods are substantially  
9 made in the United States.”.
