## A BILL

To amend the Consolidated Farm and Rural Development Act to reauthorize rural cooperative development grants.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

**3 SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Strengthening Rural  
5 Cooperatives and Communities Act”.

**6 SEC. 2. REAUTHORIZATION OF RURAL COOPERATIVE DE-**

**7 VELOPMENT GRANTS.**

8       Section 310B(e) of the Consolidated Farm and Rural  
9 Development Act (7 U.S.C. 1932(e)) is amended—

1                             (1) in paragraph (1), by adding at the end the  
2                             following:

3                             “(C) COOPERATIVE DEVELOPMENT.—The  
4                             term ‘cooperative development’ means activities  
5                             including outreach, education, training, and  
6                             technical assistance, to support the startup, ex-  
7                             pansion, or ongoing sustainability of new and  
8                             existing cooperatives.”;

9                             (2) in paragraph (4), by inserting “, and award  
10                             maximum points in scoring criteria to applicants  
11                             that satisfy the requirements of paragraph (5)(F),”  
12                             before “if the plan”;

13                             (3) in paragraph (5), by striking subparagraph  
14                             (D) and inserting the following:

15                             “(D) commit to providing technical assist-  
16                             ance and other services to socially vulnerable,  
17                             underserved, or distressed communities.”;

18                             (4) in paragraph (6)(B), by striking “If the  
19                             Secretary determines it to be in the best interest of  
20                             the program, the” and inserting “The”;

21                             (5) in paragraph (10), by adding at the end the  
22                             following: “The Secretary shall analyze the data re-  
23                             sulting from the research, and include the data and  
24                             the analysis in the annual report submitted by the  
25                             interagency working group under paragraph (12).”;

1                         (6) in paragraph (12), by adding at the end the  
2                         following: “Not later than 180 days after the date  
3                         of the enactment of this sentence and annually  
4                         thereafter, the interagency working group shall sub-  
5                         mit to the Congress a report describing the activities  
6                         carried out by the working group.”; and

7                         (7) in paragraph (13), by striking “2014  
8                         through 2023” and inserting “2024 through 2028”.
