## A BILL

To require the Administrator of the Small Business Administration to submit a report on recipients of assistance under the paycheck protection program and the economic injury disaster loan program, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-  
2 tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Small Business Trans-  
5 parency and Reporting for the Underbanked and Tax-  
6 payers at Home Act” or the “TRUTH Act”.

1   **SEC. 2. FINDINGS.**

2       Congress finds the following:

3           (1) The President has not nominated and the  
4       Senate has yet to confirm a Special Inspector Gen-  
5       eral for Pandemic Response as was required by the  
6       CARES Act.

7           (2) The CARES Act and Paycheck Protection  
8       Program and Health Care Enhancement Act were  
9       the largest outlay of taxpayer money in the history  
10      of the United States.

11          (3) The American people demand and deserve  
12      responsible stewardship.

13   **SEC. 3. SENSE OF CONGRESS.**

14          It is the sense of Congress that the Small Business  
15     Administration must provide immediate transparency over  
16     all areas of its administration of the Paycheck Protection  
17     Program (PPP) and Economic Injury Disaster Loan pro-  
18     gram (EIDL).

19   **SEC. 4. REPORT.**

20          Not later than 30 days after the date of the enact-  
21     ment of this Act, the Administrator of the Small Business  
22     Administration shall make publicly available, in an online  
23     format that is sortable and searchable for key words and  
24     downloadable (to the extent technically practicable), the  
25     following information with respect to the paycheck protec-

1 tion program and the economic injury disaster loan pro-  
2 gram:

3 (1) An identification of each recipient of assist-  
4 ance from funds appropriated under the CARES Act  
5 (Public Law 116–136) or the Paycheck Protection  
6 Program and Health Care Enhancement Act (Public  
7 Law 116–139).

8 (2) An explanation of the decision-making proc-  
9 esses under which such funds were disbursed.

10 (3) The number of employees of each entity  
11 that received such assistance.

12 (4) The date on which such assistance was dis-  
13 bursed.

14 (5) An identification of each lender or inter-  
15 mediary through which such assistance was dis-  
16 bursed.

17 (6) The amount of assistance provided to small  
18 business concerns owned and controlled by socially  
19 and economically disadvantaged individuals (as de-  
20 fined in section 8(d)(3)(C) of the Small Business  
21 Act (15 U.S.C. 637(d)(3)(C))), small business con-  
22 cern owned and controlled by women (as defined  
23 under section 3(n) of such Act (15 U.S.C. 632(n))),  
24 and small business concern owned and controlled by

1       veterans (as defined in section 3(q) of such Act (15  
2       U.S.C. 632(q))).
