# **A BILL**

To provide for the termination of employment of employees of the Internal Revenue Service who take certain official actions for political purposes.

1        *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4        *This Act may be cited as the “Prevent Targeting at*  
5 *the IRS Act”.*

6 **SEC. 2. TERMINATION OF EMPLOYMENT OF INTERNAL REV-**  
7 **ENUE SERVICE EMPLOYEES FOR TAKING OF-**  
8 **FICIAL ACTIONS FOR POLITICAL PURPOSES.**

9        *(a) IN GENERAL.—Paragraph (10) of section 1203(b)*  
10 *of the Internal Revenue Service Restructuring and Reform*  
11 *Act of 1998 is amended to read as follows:*

12            *“(10) performing, delaying, or failing to perform*  
13 *(or threatening to perform, delay, or fail to perform)*  
14 *any official action (including any audit) with respect*  
15 *to a taxpayer for purpose of extracting personal gain*  
16 *or benefit or for a political purpose.”.*

17        *(b) EFFECTIVE DATE.—The amendment made by this*  
18 *section shall take effect on the date of the enactment of this*  
19 *Act.*
