1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “BOLD Infrastructure
5 for Alzheimer’s Reauthorization Act of 2024”.

6 **SEC. 2. EXTENSION OF PROGRAM FOR PROMOTION OF PUB-**
7 **LIC HEALTH KNOWLEDGE AND AWARENESS**
8 **OF ALZHEIMER’S DISEASE AND RELATED DE-**
9 **MENTIAS.**

10 Section 398B(e) of the Public Health Service Act (42
11 U.S.C. 280e–5(e)) is amended by inserting “and
12 \$33,000,000 for each of fiscal years 2025 through 2029”
13 before the period at the end.
