Ms. MALLIOTAKIS introduced the following bill; which was referred to the Committee on the Judiciary

A BILL

To direct the Secretary of State to revoke the visas of students who have engaged in antisemitic activities, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “No Visas for Anti-
5 Semitic Students Act”.

6 **SEC. 2. REVOCATION OF VISAS OF STUDENTS WHO HAVE**
7 **ENGAGED IN ANTISEMITIC ACTIVITIES.**

8 (a) IN GENERAL.—The Secretary of State shall re-
9 voke the visa of any alien who, on the date of enactment
10 of this Act—

1 (1) is in possession of a valid unexpired visa
2 under section 101(a)(15)(F) or (M) of the Immigra-
3 tion and Nationality Act (8 U.S.C. 1101)(a)(15));
4 and

5 (2) is or has been a member of an antisemitic
6 organization, or has made public antisemitic state-
7 ments.

8 (b) DEFINITION.—In this section, the term “anti-
9 semitism”—

10 (1) means a certain perception of Jews, which
11 may be expressed as hatred toward Jews; and

12 (2) includes rhetorical and physical manifesta-
13 tions of antisemitism directed toward—

14 (A) Jewish or non-Jewish individuals or
15 their property;

16 (B) Jewish community institutions; and

17 (C) religious facilities.

18 **SEC. 3. TERMS OF NONIMMIGRANT STATUS FOR STUDENTS.**

19 Section 214 of the Immigration and Nationality Act
20 (8 U.S.C. 1184) is amended by adding at the end the fol-
21 lowing:

22 “(s)(1) An alien may not be accorded status as a non-
23 immigrant under section 101(a)(15)(F) or (M) if the alien
24 is or has been a member of an antisemitic organization,
25 or has made public antisemitic statements.

1 “(2) An alien who obtains the status of a non-
2 immigrant under section 101(a)(15)(F) or (M) and en-
3 gages in any activity described in paragraph (1) shall be
4 considered to have violated such status, and the alien’s
5 visa under such section 1101(a)(15)(F) or (M) shall be
6 void.

7 “(3) In this subsection, the term ‘antisemitism’—

8 “(A) means a certain perception of Jews, which
9 may be expressed as hatred toward Jews; and

10 “(B) includes rhetorical and physical manifesta-
11 tions of antisemitism directed toward—

12 “(i) Jewish or non-Jewish individuals or
13 their property;

14 “(ii) Jewish community institutions; and

15 “(iii) religious facilities.”.
